Student Learning Objectives: MATH 2312 helps students develop critical thinking, communication, and empirical and quantitative skills by focusing on student understanding of key mathematical concepts required for calculus readiness to include recognizing, identifying, solving, analyzing, explaining, and appropriately modeling applicable real -world situations. Upon completion of this course, students will:

- 1. Demonstrate understanding and knowledge of properties of functions from graphical, tabular, symbolic, or verbal representations.*
- 2. Identify and apply appropriate strategies for solving equations involving algebraic, transcendental, and trigonometric functions.*
- 3. Interpret and apply graphing techniques to algebraic and transcendental functions.*
- 4. Compute and apply the values of trigonometric functions for key angles in all quadrants of the unit circle measured in both degrees and radians.*
- 5. Prove and apply trigonometric identities. 6. Interpret and solve applications related to right and oblique triangles.*

List of Topics: Topics to be covered include but are not limited to the following:

- 2. Exponential and logarithmic functions, and their properties*
- 3. Exponential and logarithmic equations with applications*
- 4. Angles and their measures*

- 7. Graphs of sine, cosine, and other trigonometric functions*
- 8. Inverse functions and inverse trigonometric functions*
- 9. Applications of trigonometric Functions*
- 10. Trigonometric identities*
- 11. Trigonometric equations*
- 12. The laws of sines and cosines*
- 13. Polar coordinates and graphs of polar equations*
- 14. Vectors and dot product*

The instructor reserves the right to modify/update the topics as appropriate.

Course Requirements and Expectations

Class Attendance: Students are expected to attend lectures regularly. Be aware of what has been covered in every class and any announcements and course policy changes made in class. Announcements and changes will also be communicated through Blackboard. You are welcome to ask questions during my office hours; however, it is your responsibility to learn the material.

*Learning New Content In this face-to-face class, your instructor will hold **two lectures each week** during our scheduled class time. If you miss a class meeting, be sure to reach out to a classmate for the class notes, or you may also review the relevant material in the textbook. Regular class attendance is strongly recommended, as missing class regularly may make it difficult to keep up with the weekly homework and quizzes.*

Homework: Most homework and some quizzes will be completed online in MyMathLab (MML), along with occasional assignments or activities posted in Blackboard. You will need an access code that is available in Blackboard –Read the announcements in Blackboard for all instructions. All due dates are listed in MML. You can complete the assignments until 11:59 pm of the due date listed. The homework may be attempted multiple times in order to increase your homework grade. No late assignments will be accepted nor make-ups allowed. Please plan ahead to be sure you meet the deadlines. If you are consistently struggling with the deadlines, please reach out to me so that we can discuss possible solutions.

*Quizzes: Quizzes are given **in recitation class and online**. When quizzes are administered online, students may attempt each quiz **up to three times**, and each attempt has a time limit. Only the **highest score** will be counted. Students are encouraged to attempt the quiz multiple times to improve their grades and prepare for the unit test. **No late assignments will be accepted, and no make-up quizzes will be allowed.** At the end of the semester, the **lowest quiz grade will be dropped.***

Tests: Three unit tests are scheduled during the semester and a comprehensive final exam. All exams will be given in class and will extend through the designated help session (recitation) time to allow for extended testing time. You should show all work in order to get full credit for the problems. Students will be allowed to use a scientific calculator on the tests. In case you miss an exam or find out that you will miss an exam, you should contact me either in person or by e-mail, at least one week in advance of the exam for non-emergency cases or within 24-hrs of the scheduled exam date for emergency cases. Any missed exam counts as a 0 unless the student has a valid documented excuse and contacts me as soon as possible after the excuse for missing the test arises. Examples of valid documented excuses are sickness documented with a doctor's note, death in the family documented with a copy of the death notice, attending university-sponsored events with a Dean's excuse, etc. Minor headaches or attending sports events (without Dean's excuse) are not examples of emergency situations. Other than described above, no make-up exams will be given, but the final exam can replace your lowest test grade. Test dates are listed below. Final Exam: In order to pass this class students must take a comprehensive final exam scheduled during Finals Week. Final exams cannot be rescheduled or missed (for dire and unforeseen medical or family emergencies, students must consult with me). The final exam will also be taken in a classroom setting, with work submitted to justify your solutions. The final exam may be used to replace your lowest regular exam grade. The final exam must be completed by the announced due date. No exceptions.

Gradebook: The gradebook in MML will keep a running average of your grade. NOTE: The gradebook in Blackboard is not weighted and should only be used to review individual grades, not to assess your overall course grade.

CLASS RULES

- 1. Regular participation and attendance is VERY IMPORTANT in this class! You are enrolling in a FOUR HOUR math course (3 hour lecture + 1 hour recitation), so expect to work on your Math work very regularly. Waiting to work on one day at the end of the week would be disastrous for this course!! Assignments will be broken up into two lessons each week, with staggered deadlines for the online HW.*
- 2. Please do not ask me to extend the due dates. Work ahead on the assignments instead (remember... if something can go wrong, it will).*
- 3. If you need additional help, please ask! Your instructor is available to help, and students also have access to free on campus or online tutoring through the Academic Learning Center. 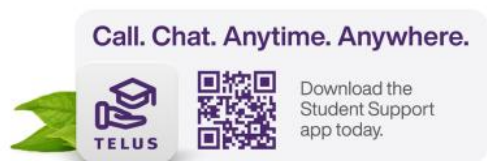

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance.
