Catalog Course Description: This course will introduce students to the concept of organizational management and the unique challenges of managing the small or startup business. Among the major topics in this class, we will discuss the process of management, the various managerial activities, strategy and decision-making, human behavior and motivation theories, ethics, globalization, diversity, teams, crisis management, human resource management, managing growth and expansion, the unique management challenges of family businesses, and succession issues and planning. Prerequisite(s): Completion of the College of Business prerequisites, MGMT 3370. TSI Restriction(s): Math.

Prerequisites: MGMT 3370 must be completed first and must meet College of Business prerequisites: ACCT 2301, ACCT 2302, ECON 2301, ECON 2302, BUAD 2310, BUAD 2305, and CISA 1305 (for CISA majors: CSCI 1336 or 1337) with a grade of 'C' or higher must be completed first or ACCT 2301, ACCT 2302, ECON 2301, ECON 2302, MATH 1325, and CISA 1305 (for CISA majors: CSCI 1336 or 1337) with a grade of 'C' or higher must be completed first.
