Catalog Description and Prerequisites:

BIOL 3306 Microbial Pathogenesis

Credits: 3 (3-0-0)

Many microorganisms have the potential to cause disease. An understanding of the mechanisms that promote bacterial pathogenesis is therefore essential for the development of effective disease prevention and/or treatment strategies. This course will explore the mechanisms by which microbial pathogens adhere to, invade, and persist in the human host. While an emphasis will be placed on microbial mechanisms of disease, the host response to the infectious process will also be discussed. TSI Restriction(s): Reading, Writing, and Math

Prerequisites: BIOL 2411 and BIOL 2421.

Restrictions: Graduate level students may not enroll.

Learning objectives

1. Student will be able to discuss the basic principles of immunity including cell types, receptors, and mediators of innate and adaptive immunity.
2. Students will be able to discuss and provide examples of how microbial pathogens evade and/or manipulate the host response for their advantage.

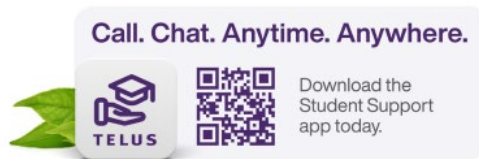

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
