COURSE DESCRIPTION:

Examines methods of crime and justice research. Topics include the nature of scientific inquiry, framing a research problem, choosing a research design, developing hypotheses, sampling designs, and measuring variables

COURSE PREREQUISITES:

CRIM 1301, CRIM 2330, and ENGL 1302 must be completed first.

LEARNING OUTCOMES:

Knowledge – Students should be able to: define the role of research and methodology in the field of criminal justice and criminology, properly label variables as independent, dependent, etc., accurately cite sources they use in their work in APA style, and recall the basic definitions and understandings of course concepts.

Comprehension – Students should be able to: describe complex experimental designs and discuss multifaceted ethical issues and dilemmas regarding the criminal justice field and criminological research.

Application – Students should be able to apply course concepts to research and practice in criminology, addressing both scientific analysis and ethical concerns.

Analysis – Students should be able to: analyze various materials to draw conclusions about ethics and research design and examine the quality and methodological soundness of research and practice in criminal justice.

Evaluation – Students should be able to evaluate the methodological rigor of research, particularly in criminal justice and criminology, and defend their arguments for why specific methodologies are or are not appropriate.

Synthesis – Students should be able to create a research proposal based on course concepts, which they will work on throughout the semester.

WRITING OBJECTIVES

By the end of this course, you should be able to:

1. **Describe** and **analyze** the structure and conventions of an academic journal article to understand disciplinary expectations.
2. **Synthesize** criminological literature to construct a literature review that justifies the value of your research question.

3. **Construct** a research proposal through multistage drafting that describes how you would answer your research question using a research method.
4. **Reflect** on the writing and research process to identify personal strengths and areas for growth as a researcher.

Note: The instructor is not solely responsible for assuring students meet these outcomes. It requires effort and input from the students as well. Students are solely responsible for managing their enrollment status in a course and must withdraw on their own. Therefore, not showing up for class does not automatically constitute a withdrawal.

COURSE REQUIREMENTS:

Students can earn up to a total of 100 possible points for the semester. In this case, the students' final percentage grades are equivalent to the number of points they earn throughout the course.

1. **Low Stakes Writing Assignments (30% or 30 points):** There will be three "low stakes" writing assignments across the course of the semester, consisting of a Research Question assignment, a Literature Review, and a Methods Outline. These three smaller assignments will help you prepare for the final project and will ultimately be major components of said final project. It is imperative that you pay close attention to and apply the feedback you receive on these portions to perform well on the final project. While more information will be provided as the semester progresses, the following is general information for each portion, along with the individual percentage weight toward the course's final grade.
 - a. **Research Question (10% or 10 points):** Students will create a research question that is testable, realistic, and that will serve as the basis for the rest of the project assignments. Students will first draft a potential research question (5 points), which the instructor will evaluate. Students will then need to revise their research question based on instructor feedback and resubmit it by the due date indicated on Blackboard and the syllabus schedule (5 points). If the instructor's feedback indicates that the question is good to go as is, the student will simply resubmit the same research question. If students do not pass the revised research question check, they must work with the instructor to obtain an approved research question before the deadline for the next project portion to continue to the next assignment. The student's grade for the failed revision will remain unchanged. See the assignment instructions for more information.
 - b. **Literature Review (10% or 10 points):** Students will be tasked with creating a literature review similar to those found in academic research articles. As part of this, students will need to find, cite, and properly assess **three** academic journal articles, summarizing their key methods and findings and integrating them into a brief discussion of how they inform the student's research question (8 points). Students will then be assigned to provide peer reviews of three other students' literature reviews to offer

ideas and gather ideas from their colleagues that they can apply to their own work (2 points). See the assignment instructions for more information.

- c. **Methods Outline (10% or 10 points):** Students will need to create an outline of what will become their methods section in the final project. Students will elaborate on the methodology they would use in their proposal, including their sample, experimental design, and proposed analysis. This will not be the full methods section of the final project, but rather a set of bulleted sections and summaries that will eventually form the methods section. See the assignment instructions for more information.
2. **Final Project: Research Proposal (30% or 30 points):** The final project will be a research proposal featuring the three major portions completed throughout the semester, along with some additional requirements and details. Students should incorporate all feedback they have received on the major assignments throughout the semester. As such, students will be graded more harshly for any mistakes that persist despite prior feedback. This project will have many specific components and requirements, as outlined in the instructions. Most of these will mirror those originally required in the previous assignments, but students should pay extremely close attention and double-check that they have accurately completed all components of the project to have the best chance of doing well on it. See the assignment instructions for more information.
3. **Exams (40% or 40 points):** There will be a Midterm Exam and a Final Exam, with each counting for 20% of the student's overall grade. These exams will not be cumulative. Instead, the Midterm will cover any course material up to the exam date, and the Final will cover any course material covered after the Midterm. Both exams will cover material from the weekly readings and material. Further, the questions themselves will draw predominantly from previous weekly quizzes. Therefore, reviewing the quizzes is a good way to study for the exams. The exams will consist of 40 multiple-choice questions each, and students will be timed in completing them.

Students are expected to complete exams on time and will not be given extra time should they start late.

Make-Up Exams: Make-up exams will only be given when arrangements have been made with the instructor and the student misses the exam due to an acceptable absence. The exam must be made up at a time convenient for the instructor, and the student must contact the instructor to schedule it within three days of the exam's due date.

Late assignment/exam submissions will not be accepted.

All assignments must be turned in to the instructor during class time or via Blackboard as instructed.

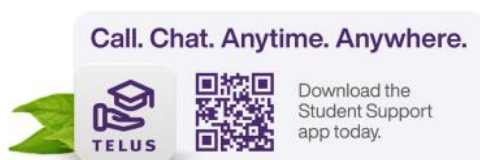
