Course Description

Physical chemistry provides the fundamental concepts and organizing principles that underlie all aspects of chemistry and related fields. It develops rigorous and detailed explanations of central, unifying concepts in chemistry and contains mathematical models that provide quantitative predictions. Topics covered include thermodynamics, kinetic theory, solutions and phase equilibria, chemical equilibrium, photochemistry, chemical kinetics and atomic and molecular structures. Prerequisites: CHEM 2325, PHYS 2326, MATH 2314 with a C or better. Corequisites: CHEM 4101. TSI Restriction(s): Reading, Writing, and Math Restrictions: Graduate level students may not enroll.

Learning Objectives

By the end of the course, students will be able to:

1. Apply kinetic theory and equations of state to ideal and real gases.
2. Calculate heat, work, energy, enthalpy, entropy, and free-energy changes.
3. Use thermodynamic principles to analyze reactions, mixtures, and phase equilibria.
4. Determine chemical equilibria and evaluate temperature and non-ideality effects.
5. Apply electrochemical thermodynamics and the Nernst equation.
6. Analyze rate laws and integrated kinetic data.
7. Evaluate reaction mechanisms using appropriate kinetic approximations.
8. Use partition functions and statistical mechanics to derive thermodynamic properties.

Conceptual Topics Covered

This course covers the kinetic theory of gases, Maxwell–Boltzmann distributions, and the behavior of ideal and real gases. It introduces heat, work, internal energy, enthalpy, entropy, and the laws of thermodynamics, including calorimetry and Helmholtz and Gibbs energies. These principles are applied to reactions, mixtures, solutions, phase equilibria, chemical equilibrium, and electrochemistry. The course also examines chemical kinetics, rate laws, reaction mechanisms, kinetic approximations, reaction dynamics, ensembles, molecular partition functions, and statistical thermodynamics.

Course Materials

Textbook: Physical Chemistry: Thermodynamics, Statistical Thermodynamics, and Kinetics (4th ed) by Thomas Engel and Philip Reid (ISBN 9780136781417). Students may also purchase additional textbooks of physical chemistry, if they prefer to use one.

Calculator: Any calculator is acceptable.

Grading

Your final grade will be based on two exam (midterm and final exams) and a presentation. Each student will give a 20-minute oral presentation using slides on a topic closely related to the conceptual material covered in the course. Students must consult the instructor and receive topic approval before preparing the presentation. The presentation should explain the relevant physical chemistry principles, connect them to a specific application or research question, and discuss important assumptions or limitations. Grades will be based on scientific accuracy, depth of understanding, organization, slide quality, delivery, and effective use of sources.

Exams: 2 x 100 points each = 200

Presentation: 60 points

Class policies

Communication: The best way to contact me is through email. Students are expected to access Blackboard for updates on the course, announcements and other course materials. All students are strongly encouraged to come to office hours or make appointments at other times to discuss course material and answer questions.

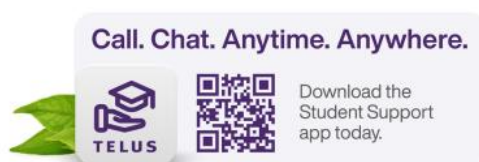

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds
