Course Description

This course will provide an overview of the field of social psychology. Different topics within social psychology will be presented. For each topic, personal factors, situational factors, and the interaction among these will be discussed. Students will obtain an understanding of multiple areas of social psychology and will learn to critically apply social psychology concepts to everyday life.

Especially when it comes to clarifying assignment instructions and/or submission requirements. In all communications, please be professional in your tone and specific in your message (i.e., avoid informal correspondence styles like text messaging which lack appropriate punctuation and capitalization). Your correspondence **MUST** include the information specified above. If you send an email without sufficient information, I likely will not reply or may reply asking for clarification about your inquiry (this can result in an unnecessary delay). Please begin a new email thread instead of responding to older emails if you are beginning a new conversation unrelated to the previous email (this helps minimize confusion caused by chain replies).

- **Office Hours:** I will be available in my office (STEM 249B) to meet during office hours (see above) or by appointment. Office hours are dedicated to interacting with and providing students assistance regarding coursework. An appointment is not necessary to attend these hours, but interactions are limited to a first-come, first-served basis. If there is a specific assignment/materials or topic you want to discuss, providing advance notice will allow me to have these resources ready. If students cannot meet during these times, an alternative time can be requested via email, and I will do my best to try to accommodate students accordingly. For discussions involving more personal and/or sensitive information, some form of advance notice is recommended.

Assessment and Evaluation

All assignments, except for in-class discussions/activities, will be administered from and turned into Blackboard. No paper copies will be accepted unless otherwise noted. Late work will not be accepted without a university-approved excuse and/or advance notice with instructor approval. Additionally, you are expected to complete all work independently. The following descriptions are intentionally brief. Detailed instructions will be available in class and through Blackboard throughout the semester. Each assignment will have a specific set of instructions students will be required to follow.

- **Homework Assignments:** Six homework assignments will be administered throughout the semester, each worth 20 points. The topic/format of the homework assignment will depend on the content for the week. These homework assignments will be completed outside of class. Homework assignments are open book, meaning you may use assigned readings, lecture materials, and other course resources provided by the instructor. Any assignments requiring writing may be submitted through plagiarism and AI detection software.
- **Exams:** Four exams will be administered, each worth 80 points. Exams will be non-cumulative. The exams will have questions that will vary in format (e.g., multiple choice, fill-in-the-blank). Exams will only be offered on the dates and times listed in the course schedule. There are no make-up opportunities for the exams once the deadline has passed. The only exceptions to this policy are valid excuses for absences (see Missed/Late Assignment Policy).
- **Group Discussions/Activities:** Six group discussions/activities will be administered throughout the semester, each worth 20 points. The topic/format of the group discussions/activities will depend on the content for the week. These group discussions/activities will be completed during class. These activities are intended to reward consistent engagement and participation throughout the course. I reserve the right to award reduced or no credit if a pattern indicates that a student is attending class primarily or exclusively on days when graded in-class activities are administered.
- **Extra Credit Opportunity (Research Participation):** You may participate in a psychology research study or attend a speaker series talk. One SONA credit is worth 10 points. This extra credit opportunity can be completed only two times.

Financial Aid and Verification of Attendance

does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Informed Consent

Social Psychology Course

This course provides an in-depth exploration of how other people – real, imagined, or implied – influence our thoughts, feelings, and actions. Understanding these influences requires us to consider characteristics of ourselves, others, and the social contexts in which interactions occur. Please read the following information carefully to understand the nature of the course.

- **Topics:** Social psychology encompasses a wide range of topics, some of which may be considered sensitive or controversial (e.g., gender, race and ethnicity, aggression, culture, climate change, current events such as political elections). Discussions of these topics will be grounded in psychological theories and empirical evidence. Students are not expected to change their personal beliefs or adopt any ideological position.
- **Class Discussions and Assignments:** Students are expected to engage respectfully with differing perspectives and critically evaluate claims using scientific evidence. Some material may challenge existing beliefs or cause discomfort. Students will be evaluated on their understanding and application of course material, not on agreement with the instructor or adoption of a particular viewpoint.

This course is an elective and not required for graduation or completion of the psychology major. BY CONTINUING YOUR ENROLLMENT IN THIS COURSE, YOU ACKNOWLEDGE AND ACCEPT THE NATURE OF ITS CONTENT.
