COURSE DESCRIPTION

Laboratory course to reinforce and apply concepts introduced in [PSYC 4310](#) Cognitive Psychology.

Prerequisites: [PSYC 2301](#) and [PSYC 2388](#) . **Corequisites:** [PSYC 4310](#).

Restrictions: Graduate level students may not enroll.

COURSE OBJECTIVES

1. To better students' understanding of research methodologies used to study mental activity
2. To encourage critical thinking and analysis of cognitive theories and their implications
3. To examine practical applications of cognitive principles to real-world activities

GRADES

All assignments will be submitted through Blackboard, and instructions/rubrics will be available on Blackboard unless otherwise noted.

Assignments are due the following class period unless otherwise stated.

There are 10 graded labs worth 30 points each (for lab write up, a rubric will be provided). Attendance will be worth 20 points total for the semester with each attendance being worth 1.25 points. Students may miss one class without penalty, but any additional unexcused absence will result in a loss of points.

Your final grade in this class will be calculated as a simple average: your points earned divided by the maximum number of points you could have earned.

Grade Cutoffs: A = 90, B = 80, C = 70, D = 60, F < 60.

All written work should be of academic quality submitted in APA format to expect full credit.

LAB WRITE UPS & ACTIVITIES

Some of the labs will consist of activities you complete this semester will be used to collect data that will be later analyzed and interpreted using appropriate statistical tests. Data collection days require students to be in attendance and contribute to the data. Typically, there will be a series of follow-up questions students will also need to answer and submit as part of their participation in these sessions.

When data are analyzed, students will be expected to write up a lab report in accordance with APA guidelines. Typically, these lab reports will include a Method, Results, and brief Discussion section and may require students to read additional research articles. More specific assignment guidelines will be posted/provided via Blackboard and will be found in the corresponding folder under Course Content. On average, these lab reports will be about 2-3 pages including a title page.

LATE WORK

Late work will not be permitted without prior authorization and/or approval for excused absences.

WITHDRAWAL POLICY

Any withdrawals after the last day for an automatic “W” date established by the university will receive the grade of “F”.

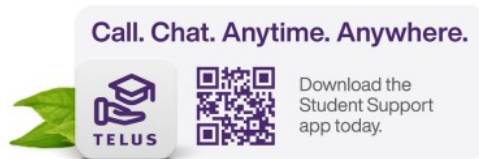

FINANCIAL AID AND VERIFICATION OF ATTENDANCE: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. STUDENTS' RIGHTS AND RESPONSIBILITIES: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built.
