Catalog Course Description: Selected statistical methods involving quality control, forecasting, sampling and other business applications using computer-based approaches.

Course Objectives: The objective of the course is to prepare the students to analyze data for making various business decisions. The students will gain the knowledge required for understanding the modern tools and methods used in the field of applied statistics and economics.

Prerequisites: None

Student Learning Outcomes:

After successful completion of the course, the student will be able to learn these: 1) Graphical and numerical analysis of data using descriptive statistics. 2) Concept of probability and probability distributions of discrete and random variables. 3) Statistical inference using confidence interval, test of hypothesis, and regression analysis.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance.
