Course Information

- Course Overview
- This class focuses on a critical analysis of the concepts of race and ethnicity; the formation of racial and ethnic identities; the imposition of identities on groups and individuals; and the dynamic nature of racial and ethnic labels. Students study the social histories of racial and ethnic groups in the U.S. and examine the social-political processes through which people are continuously defined and redefined.
- Prerequisite SOCI 1301, SOCI 1306, or ENGL 1302 must be completed first.

Upon Completion of this Course, students will be able to:

- Define the major sociological concepts applicable to racial and ethnic identity, intergroup relations, prejudice, discrimination, racism in the American context.
- Describe the diversity and inequality among various social groups in the U.S along various social contexts: education, health, sports, politics and crime.
- Apply sociological theories and models to explain various social groups related to social phenomena and issues.
- Explain the dynamics of power relationships among different social groups and how various social groups have expressed agency in the face of marginalization in American society.

Course Requirements

Class Participation

Participation is paramount in your academic thus it is important that a part of your grade captures your participation in the course. Students are expected to

come to each class with the assigned readings ready to engage with Dr. Malone and other peers. I periodically give pop quizzes to gauge if students are abreast of course readings.

Class participation includes, not limited to, pop quizzes, documentaries assignments, in-class activities, and online work. Of course, this also includes attendance. When it comes to online work, particularly discussion forums, each student is required to write an original post responding to the prompt and addressing it fully for credit. Term Paper and Presentation

Students will develop an eight-page minimum scholarly research paper/policy analysis (excludes cover page and reference page) of their topic of interest. This project will be submitted in parts over the course of the semester. Students will present research at the end of the semester. More details to follow on Blackboard Ultra

Exams

You are responsible for taking 3 exams in this course. Each exam will evaluate you on the material covered directly prior to the exam. Exams are not cumulative. Exams are available through Blackboard Ultra. Approach taking your online exams as if Dr. Malone were right next to you. This means you are to receive no outside assistance nor use notes. You will have 75 minutes to complete the exam.

Late Assignment
