Course Information

- Course Overview
 - This course is the culminating experience of the sociology major. Students will synthesize previous learning to conduct a semester-long research project. This course will develop writing, peer review, and presentation skills so that students produce a final research paper which will be presented in a public showcase.

Upon Completion of this Course, students will be able to:

- Integrate past learning by making connections between known sociological knowledge and your research
- Improve reading, research, and writing (synthesis, citation, and revising) skills appropriate to the discipline of Sociology
- Develop presentation skills
- Develop conclusions supported by empirical evidence and theory and effectively communicate them orally and in writing
- Produce a research paper
- Develop collaboration skills through constructive comments and suggestions at each stage of the research process

Class Participation

Participation is paramount in your academic thus it is important that a part of your grade captures your participation in the course. Students are expected to come to each class with the assigned readings ready to engage with Dr. Malone and other peers. I periodically give pop quizzes to gauge if students are abreast of course readings.

Class participation includes, not limited to, pop quizzes, documentaries assignments, in-class activities, and online work. Of course, this also includes attendance. When it comes to online work, particularly discussion forums, each student is required to write an original post responding to the prompt and addressing it fully for credit. Steps to the Capstone

Your capstone will be completed in parts so that you do not lose track of progress throughout the course. These steps will include drafts of various parts of the projects: topic choice and research questions, introduction, literature review, data and methods, and expected findings. Introduction, literature review and data and methods are

required to be sent to the Writing, Language, and Digital Composing Center for review.

Special Topics- Student Driven

As a part of the capstone experience, I dedicate a portion of the course to being “student driven” when it comes to teaching a class about a sociological topic that is not covered in the course. Students are encouraged to pick a topic they can teach to the class in about 20 minutes where sociological theories, arguments, and key findings from sociology scholars are covered. There should be a PowerPoint presentation. Topics should be approved before beginning research.

Exams

You are responsible for taking 2 exams in this course. Each exam will evaluate you on the material covered directly prior to the exam. Exams are not cumulative. Exams are available through Blackboard Ultra. Approach taking your online exams as if Dr. Malone were right next to you. This means you are to receive no outside assistance nor use notes. You will have 75 minutes to complete the exam. If technical issues arise, please contact me as soon as possible.

Presentation and Reflection

Each student will provide a presentation to the Jaguar Community. These presentations should reflect the work you have done over the course of the semester. Business Casual attire is the standard for your presentation day. Our presentations will mimic a sociology conference in form and structure.

Reflections will be your account of your experience in the Capstone course. This assignment should reflect a serious engagement of the student’s growth throughout the course. There will also be a Qualtrics Exit Exam for each student to take that is not for a grade but a required portion of the course. It is a tool for the Sociology department to assess our student’s experience, acumen, and our program objectives and outcomes.

Capstone Project

Each student will write a research paper/policy analysis project (20-page minimum) on a topic of the student's choice and apply several sociological theories and research methodology to demonstrate a deep understanding of how sociology is relevant to understanding our contemporary society. Attendance and Tardiness

Class periods are comprised of both lecture and discussion. Thus, your attendance is essential to success in this course. However, unexpected events do arise which may prevent you from attending. For this reason, you will be allowed 3 unexcused absences or what I call "self-care" days. All additional unexcused absences will result in a

one-letter grade penalty per absence. In the event of any absence, I encourage you to retrieve course lecture notes from your peers.

There may be occasions (inclement weather or other unforeseen events) when Dr. Malone cancels class and/or TAMUSA is closed. In these events, I will communicate at my soonest convenience to students via email directing you to Blackboard Ultra where alternative coursework will be available.

Late Assignment

All assignments are due by the specified time on Blackboard Ultra. Any assignment turned in after the deadline is considered late and will receive a standard deduction of 10 points. After 1 late day, the assignment will be a "0" unless there is a university excused reason.

Students who do not have a university-excused absence will not be allowed to make up a missed examination. You must have written documentation for the absence and have notified the instructor within 24 hours of the absence to be able to schedule a make-up exam. No exceptions.
