Course Description:

Introductory course to statistical reasoning and social science statistics commonly used in criminal justice research. Students will learn how to analyze and interpret quantitative data. Includes introduction to descriptive and inferential statistics.

Prerequisites: CRIM 1301, CRIM 2330, ENGL 1302, & MATH 1314 or 1342

Course Learning Objectives:

- By the end of this course, students should be able to calculate and interpret basic social statistical tests, including:
 - Descriptive statistics.
 - Measures of association.
 - Statistical inference.
 - Hypothesis testing.
 - Regression.

Assessments

Attendance:

You are expected to attend EVERY class and actively participate in class discussions and activities. If you must miss class, please let me know **beforehand** with proper documentation. During class, we will have in-class handouts, take-home assignments, and statistics software assignments. If you miss class, you are responsible for catching up with the class on your own. Chapter notes of the textbook will be provided on BlackBoard in case you miss a class. If you miss a class without a proper documentation, there will be no late submissions of assignments.

Participation:

You are expected to fully participate in class exercises. Be ready to answer the questions that I will ask you during class.

Assignments (30% of grade):

You will complete 10 written assignments during lectures. In-class assignments will be 15 points each, resulting in 150 points total.

Software Assignments (10% of grade):

You will complete 10 software assignments worth 6 points each and 60 points total, many utilizing the “Computer Exercises” at the end of the chapters in our textbook, but full information for each assignment is on BlackBoard. You will use the “General Social Survey (GSS) 2010 data provided on BlackBoard. The dataset and codebook are available on Blackboard under “Statistics Software” with the filenames “GSS 2010 for 4E-1.sav” (dataset file) and “Codebook for GSS 2010 Fox4e.pdf” (codebook).

*****NOTE:** The number of software assignments may be reduced depending on the instructor’s discretion.

Exams (60% of grade):

There will be Six exams (50 points each) during the semester. It will include a mixture of multiple choice, fill in the blank, and matching problems. It will also involve hand calculations and interpretations, and statistics software output requiring interpretations and identification.

Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. The Six-Drop Rule

Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
