Course Description: This course is about water treatment technologies and new strategies for advanced recycling of gray water wastes, as well as innovative uses of black water and industrial effluents will be explored.

Learning Outcomes: This course is to familiarize the student with the principles of wastewater treatment unit operations and its systems, as well as the state-of-the-art water treatment processes for emerging contaminants and geographically unique pollution-control challenges. Specifically:

- a. Students will demonstrate the ability to communicate scientific information through oral and written formats;
- b. Students will gain a familiarity with concepts of wastewater characterization, physical, chemical, and biological treatment processes over the course of the semester;
- c. Students will gain experience in conceptual design of wastewater treatment; and
- d. Students will be able to use and understand the primary scientific literature

associated with the treatment of specific types of wastewater.

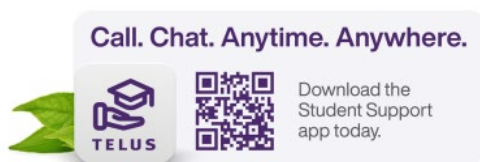

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal

financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Students' Rights and Responsibilities: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built.
