**Course Title:** Pollutants Environmental Systems

**Course Description:**

This course explores the fate, transport, and impacts of environmental pollutants, emphasizing chemical, physical, and biological processes that govern pollutant behavior. Students will study methods of environmental toxicology, risk assessment, and causal relationships between pollutants and environmental or human health outcomes. The course provides a foundation for understanding contaminant interactions in air, water, and soil systems, as well as strategies for monitoring, mitigation, and removal of pollutants.

**Learning Outcomes:**

Upon completion of this course, students will be able to:

- a. Communicate scientific information related to environmental pollutants effectively in both oral and written formats;
- b. Demonstrate understanding of environmental toxicology principles and the causal relationships between pollutants and environmental or human health effects;
- c. Apply methods of environmental sampling, exposure assessment, and chemical fate analysis;
- d. Analyze the behavior of pollutants in air, water, and soil systems, including hydrophobic and inorganic chemicals;
- e. Evaluate strategies for chemical removal and mitigation of hazardous substances;
- f. Critically assess primary scientific literature on environmental pollutants and propose evidence-based solutions to environmental contamination challenges.

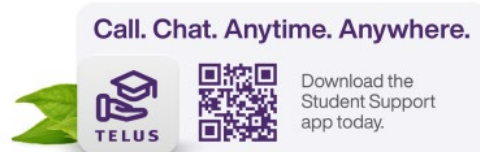
