Catalog Course Description: The course will build on financial management concepts introduced in FINC3337. Topics covered will include cost of capital, capital budgeting, capital structure, dividend policy, stock repurchase, credit management and risk management using derivatives.

Prerequisite: FINC3337 or FINC 3310.

Course Objectives: Students will leave the course with a basic understanding of the theoretical concepts underlying financial management as well as the technical and analytical tools used to answer the primary questions of individual and corporate finance: How much to invest in what projects and how best to raise the money to pay for those investments. While the concepts and tools we will study in this course relate to corporate finance, they have broad applicability in any study requiring the determination of a present value of future financial events or cash flows. The tools we will use include the algebraic formulas that evaluate present and future value, and the financial calculators and spreadsheet applications that perform the statistical and time value of money calculations.

Prerequisites: FINC 3337. Students who do not meet the pre-requisites must contact the instructor immediately.

Student Learning Outcomes:

After successful completion of this course, students will be able to:

- 1) Calculate the value of financial assets such as stocks and bonds using quantitative and qualitative analysis
- 2) Evaluate the risk and return characteristics of financial assets, to assess strategic capital budgeting
- 3) Analyze the risk and return characteristics of investment projects using financial theories and methods
- 4) Explain the complexities of financial decisions that affect company performance and value through an ethical, global, economic and regulatory context

- 5) Understand the use of debt and dividend policy of companies through the use of financial theories and methods
- 6) Analyze the financial planning process of corporations through strategic management.

AACSB Assessment:

The College of Business is in the process of applying for AACSB accreditation. As part of that process, students will be assessed on program level outcomes based on course outcomes from various courses. The materials from this course may be used for assessing such program level outcomes, and hence students must follow the necessary rigor to ensure mastery and retention of the above course outcomes.

- **Connect:** Online homework will be administered through Connect. To use Connect, just go to Course Content in the Blackboard and there is a link. It will lead you to the Connect assignments.

Other Recommended / Reading Materials: Students should keep current with various business news through such publications as the Wall Street Journal, The Economist, and various news programs. The latter would include Fox Business News, Bloomberg TV, and the nightly business report on NPR.

Course Requirements every student must fulfill in order to succeed in course:

1. Students should check the Course Calendar, Announcements, and Messages (e-mail) systems in Blackboard on a regular basis.
2. Students should keep current with all course assignments, quizzes, and examinations.
3. If the course uses remote proctoring for exams, students must schedule their exam early in the semester.
4. Students should ask questions and communicate with the instructor either in class, online, off-line or during office hours.
5. For all classwork, exams, quizzes etc., if a student is completing it off-campus, then they are responsible for availability of internet connectivity. Extensions will **not** be granted for lack of availability of internet connections.

Grading Policy:

The final course grade will be based on your performance on the quizzes, exams, assignments and class participation using the following weights:

The final letter grades will be assigned as follows: Above 90% $\Rightarrow$ A; 80 – 89% $\Rightarrow$ B; 70 – 79% $\Rightarrow$ C; 60 – 69% $\Rightarrow$ D; Below 60% $\Rightarrow$ F.

Examinations and Quizzes: There will be two mandatory mid-term exams and a mandatory final exam (as per class schedule). Being absent for an exam will result in a grade of zero for that exam and may result in a fail grade in the course. The exams will consist of conceptual multiple-choice questions. The exam materials will come from lecture notes, the text, and class discussions. Questions will emphasize understanding and applications of concepts and topics covered in class.

Proctored Exams: Examinations in this class may/will be administered in the classroom. Details regarding proctored test and administration will be provided at least 2 weeks prior to the exam.

Assignments/ Research papers: There will be several assignments and Projects (three) during the course. Individual assignment statements and due dates will be posted through Blackboard. For all assignment and quiz problems, ALL intermediate work of the problem solution steps MUST be shown. This includes the use of the formula, the values substituted in the formulas for problem solution, as well the intermediate steps of the arithmetic computation. The units of measurement are extremely important and MUST be shown at each stage of the computation. Considerable points will be taken off for not following these requirements.

Make up and Late Assignment/exam/quiz policy: As a general rule, make-ups or late submissions will NOT be offered or accepted for any missed assignments/exams/quizzes. Late submissions or make-ups may be accepted/administered only in extra-ordinary circumstances such as an excused official university activity, a severe illness, or a dire emergency. However, you must provide comprehensive documentation either before or within a few days of the missed assignment/quiz/exam.

Class conduct and civility code: Everyone in class is expected to follow all rules in the student handbook, as well as common courtesy during classroom lectures and discussions in class and online, including the following:

1. It is the students' responsibility to obtain and be able to use the required materials and software for this class.
2. Student must retain copies of all assignments and graded work for verification purposes. Keep copies of all computer files and e-mails.

Class attendance and Participation: A vital part of every student's education is regular attendance of class meetings. Any absences tend to lower the quality of a student's work, and frequent or persistent absences may result in a failing grade. Students are responsible for the materials covered in class. The course covers a lot of material and most students find at least some parts of it difficult. Class participation is highly encouraged as it makes the class more interesting and enhances the learning experience. Students are strongly encouraged to ask questions and participate in class discussions and problem solving. Good attendance and participation will be rewarded when final grades are assigned.

The course is intensive and challenging and you are expected to master the materials presented in class. The structure of the class makes your individual study and preparation outside of class extremely important. Reading the assigned chapter(s) and having some familiarity with them before class will be very useful for understanding lectures.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
