Course Description and Materials

Catalog Description

This course provides a lab framework for exploring and reinforcing calculus concepts studied in MATH 2313 and must be taken concurrently with MATH 2313.

Prerequisite: MATH 2312 Pre-Calculus with a grade of “C” or higher or equivalent or permission of department.

Corequisite: MATH 2313.

Textbook

This course relies on the textbook used in MATH 2313 and does not require any additional reference.

Student Learner Objectives:

Upon completion of this course, students will be able to:

1. Develop solutions for tangent and area problems using the concepts of limits, derivatives, and integrals introduced in Math 2313.
2. Interpret graphs of algebraic and transcendental functions by applying concepts of limits, continuity, and differentiability at a point.
3. Apply limits in problem-solving sessions to determine and explain whether a function is continuous and/or differentiable at a point.
4. Compute derivatives of algebraic and transcendental functions using rules of differentiation.
5. Model real-world phenomena using calculus concepts and techniques.
6. Explain solutions to applied problems.
7. Evaluate definite integrals using the Fundamental Theorem of Calculus.

Assignments

This course consists of 11 lab activities. There will be no makeups for missed labs, but the two lowest scores will be dropped. Students will work in lab groups of 2 or 3 students, but each student is expected to submit a lab activity paper. Activities are due on the day assigned. If the activity is unfinished at the conclusion of class, the activity may be taken home only with the instructor's permission. In that case, the activity is due one week after it is assigned.

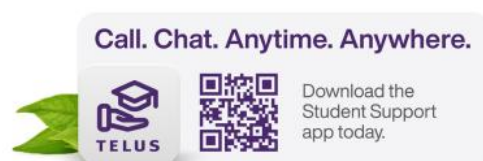

Counseling/Mental Health Resources

Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Jaguar Writing, Language, and Digital Composing Center (WLDCC)

The WLDCC provides support to graduate and undergraduate students in all three colleges as well as faculty and staff. Writing tutors work with students to develop reading skills, prepare oral presentations, and plan, draft, and revise their written assignments. Our language tutors support students enrolled in Spanish courses and students composing in Spanish for any assignment. Our digital studio tutors support students working on digital projects such as eportfolios, class presentations, or other digital multimedia projects. The WLDCC offers face-to-face, synchronous online, and asynchronous digital appointments. Students can schedule appointments with the WLDCC in JagWire under the Student Services tab. The Six-Drop Rule

Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Pregnant/Parenting Students

Texas A&M-San Antonio does not require a pregnant or parenting student, solely because of that status or issues related to that status, to (1) take a leave of absence or withdraw from their degree or certificate program; (2) limit the student's studies; (3) participate in an alternative program; (4) change the student's major, degree, or certificate program; or (5) refrain from joining or cease participating in any course, activity, or program at the University. The university will provide such reasonable accommodations to pregnant students as would be provided to a student with a temporary medical condition that are related to the health and safety of the student and the student's unborn child. Students' Rights and Responsibilities

The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built.
