Course Information

Catalog Description

This course provides a lab framework for exploring and reinforcing calculus concepts studied in MATH 2314 and must be taken concurrently with Math 2314.

Prerequisite: MATH 2313 Calculus I and MATH 2113 both with a grade of "C" or higher or equivalent or permission of department.

Corequisite: MATH 2314.

Textbook: This course relies on the textbook used in MATH 2314 and does not require any additional reference.

Course Overview

This course parallels the content of MATH 2314 Calculus II, applying advanced integrations techniques and the concepts of sequences and series to solve real-world and complex math problems.

Student Learning Outcomes

Upon completion of the course, students will be able to

- Apply advanced integration techniques (e.g., integration by parts, partial fractions, trigonometric substitution) to solve real-world or complex problems with or without computational tools.
- Evaluate infinite series for convergence or divergence using appropriate tests and compute the sum of convergent series when possible.
- Communicate mathematical ideas effectively, both orally and in writing, by presenting solutions, explaining reasoning, and interpreting results in context.
- Work collaboratively in groups to solve multi-step calculus problems, promote peer learning, enhance critical thinking, and reflect on problem-solving strategies.
- Demonstrate the ability to critique and revise solutions, incorporating feedback from peers or instructors to improve mathematical accuracy and clarity.

Assignments

This course consists of 8 labs each worth 15 points. The two lowest lab scores will be dropped at the end of the semester. Attendance will be taken at each lab session. Lab attendance is worth 10 points. Students will generally work in lab groups of 3 students and will hand in a single lab report for the entire group. Some lab periods may be applied to review of course topics at the discretion of the instructor.

While tutoring hours may change based on tutor schedules and availability, the current tutoring hours for MATH in the ALC are as follows:

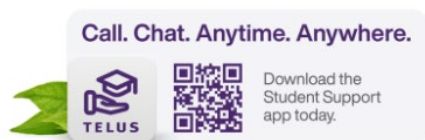

Counseling/Mental Health Resources

Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Jaguar Writing, Language, and Digital Composing Center (WLDCC)

The WLDCC provides support to graduate and undergraduate students in all three colleges as well as faculty and staff. Writing tutors work with students to develop reading skills, prepare oral presentations, and plan, draft, and revise their written assignments. Our language tutors support students enrolled in Spanish courses and students composing in Spanish for any assignment. The Six-Drop Rule

Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Texas A&M-San Antonio does not require a pregnant or parenting student, solely because of that status or issues related to that status, to (1) take a leave of absence or withdraw from their degree or certificate program; (2) limit the student's studies; (3) participate in an alternative program; (4) change the student's major, degree, or certificate program; or (5) refrain from joining or cease participating in any course, activity, or program at the University. The university will provide such reasonable accommodations to pregnant students as would be provided to a student with a temporary medical condition that are related to the health and safety of the student and the student's unborn child. Students' Rights and Responsibilities

The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. Students' Rights
