FORMAT: Meet every two weeks on Thursday 3:30-4:30pm to discuss student progress on reading, understanding assigned material, and accomplishment of related assignments.

TEXTBOOK: No fixed textbooks. Recommended books: Mathematical Biology I & II, Ordinary Differential Equations, Partial Differential Equations, Mathematical Physiology, Calculus of Variations and Optimal Control Theory A Concise Introduction (by Daniel Liberzon), or other published books or papers in mathematical modeling. Reading materials will be assigned by the instructors.

PREREQUISITE: Nine semester hours of advanced math beyond MATH 3325 or consent of the instructor or department head.

COURSE DESCRIPTION: Special topics in mathematics including mathematical biology, mathematical physiology, control theory or other areas in mathematical modeling. Mainly students are assigned reading materials to self-study, and then meet with the instructors to report their learning. Students learn basic ways how mathematical research is conducted including reference reading, research planning, research implementation, and paper writing. Students learn how math creation is made and how math communication is performed.

COURSE OBJECTIVES: This course involves students in basic math research. Students read related books or published papers to find knowledge in a special area. Students form systematic knowledge from their reference reading. Students understand how new knowledge is created from existing math knowledge, and communicate their work professionally to the academic area.

LEARNING OUTCOMES:

1. Reading relevant research books or papers to be familiarized with knowledge in a special area;
2. Identifying problems in a special area for which new knowledge can be made;
3. Understanding how basic academic papers are written;
4. Practicing writing academic papers following templates;
5. Presenting independent or collaborative research work in front of audience in a meeting
6. Promoting critical thinking and creation in mathematics.

GRADING POLICY: There will be one meeting every two weeks. Students report to the instructors what they read systematically during the two weeks. A student paper is submitted at the end of the semester. A research talk of 20 minutes reporting the reading and student paper is given at the end. The

final grade is based on the biweekly meetings and discussions (50%), student paper (25%) and talk (25%).

Grading scale: Use “T” to represent the total weighted point in a 100 scale for a student. The grading scale in a letter grade is $T \geq 90$, A grade; $T \geq 80$, B grade; $T \geq 70$, C grade; $T \geq 60$, D grade; $T < 60$, F grade.

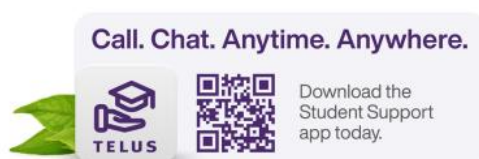

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include

class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Jaguar Writing, Language, and Digital Composing Center (WLDCC):

The WLDCC provides support to graduate and undergraduate students in all three colleges as well as faculty and staff. Writing tutors work with students to develop reading skills, prepare oral presentations, and plan, draft, and revise their written assignments. Our language tutors support students enrolled in Spanish courses and students composing in Spanish for any assignment. The Six-Drop Rule: Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Pregnant/Parenting Students: Texas A&M-San Antonio does not require a pregnant or parenting student, solely because of that status or issues related to that status, to (1) take a leave of absence or withdraw from their degree or certificate program; (2) limit the student's studies; (3) participate in an alternative program; (4) change the student's major, degree, or certificate program; or (5) refrain from joining or cease participating in any course, activity, or program at the University. The university will provide such reasonable accommodations to pregnant students as would be provided to a student with a temporary medical condition that are related to the health and safety of the student and the student's unborn child. Students' Rights and Responsibilities: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. This philosophy acknowledges the existence of both rights and responsibilities, which is inherent to an individual not only as a student at Texas A&M University-San Antonio but also as a citizen of this country.

Students' Rights

AI Policy

Use of Generative AI Permitted Under Some Circumstances or With Explicit Permission: There are situations and contexts within this course where you may be asked to use artificial intelligence (AI) tools to explore how they can be used. Outside of those circumstances, you should not use AI tools to generate content (text, video, audio, images) that will end up in any student work (assignments, activities, discussion responses, etc.) that is part of your evaluation in this course. Any student work submitted using AI tools should clearly indicate with attribution what work is the student’s work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, students should reach out to their instructor for clarification before submitting work for grading. Use of AI-generated content without the instructor’s permission and/or proper attribution in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio’s standards of academic integrity.
