

Syllabus of Mathematical Biology MATH 3372

Catalogue description: Students will investigate mathematical biology models such as population growth for single species and multiple species, infectious disease dynamics models, biochemical enzyme reactions, and biological oscillations. Appropriate mathematical techniques are applied to analyze the models and obtain solutions. Model improvement will also be evaluated for more practical modeling effects.

Experiential learning: This is a class with experiential learning. Besides regular classes, students need to participate in three community-based projects to accomplish the course. More specifically, students combine the textbook knowledge and community-based experiences for critical thinking and deep learning, and have the opportunity to join in the cycle of experiencing, reflecting, thinking and acting. The experiential learning helps students identify important factors involved in mathematical biology problems. It also assists students to reflect on how to use basic mathematical knowledge to establish appropriate models for real-world biological issues. The experiential learning facilitates evaluating models to improve future model performance.

Prerequisite: MATH 2313 Calculus I (taken with MATH 2113 Calculus I Lab) or MATH 1325 Mathematics for Business and Social Sciences II, with a grade of “C” or higher.

Required textbook: Mathematical Biology, I: An Introduction (third edition). Author: J.D. Murray. Springer. ISBN: 0-387-95223-3

Student learning objectives: Students will gain knowledge and understanding of basic modeling techniques applied to a variety of biology applications and learn the complexity of biological problems. In particular, students will:

- Identify and study various interesting mathematical biology problems;
- Identify important factors involved in mathematical biology problems and analyze their mutual relations;
- Use mathematical knowledge to set up appropriate models for variables inherent in biology problems;
- Employ mathematical analysis to analyze the models for more deep understanding of the biological problems;
- Plot the functions to illustrate a vivid understanding of the various variables to identify and analyze branching points, and increasing and decreasing areas;
- Evaluate applied models to improve performance.

List of topics: Topics to be covered may include, but are not limited to, the following areas:

- Bacterial Growth in Chemostat
- Population Growth Models, Predator-Prey Models

- Marital Interaction for Divorce Prediction and Marriage Repair
- Enzyme Dynamics
- Atherosclerosis (The Risk of High Cholesterol)
- Cancer-Immune Interaction
- Spread of Infectious Disease
- Cancer Therapy
- Tuberculosis
- Basic knowledge of systems of differential equations and numerical simulations of solutions

The instructor reserves the right to modify/update the topics as appropriate.

Experiential learning projects: This class offers three experiential learning projects at the beginning, middle, and end of the semester. The community-based experiential learning shows a learning cycle of “Do, Think, Conclude, and Adapt”. Each project takes about 7-10 hours to accomplish. All students are required to participate in the projects. Research teams can be formed. The first project is modeling population growth in the San Antonio area with death, birth, and migration, the second project is modeling the dynamics of marital interaction for divorce prediction and marriage repair, and the third one is modeling infectious disease spread-out for COVID-19. (Note: the project content may be modified based on needs.) Initially students learn basic models in the textbook to understand how mathematical models are set up, and how solutions are obtained and analyzed to interpret the models for prediction. Students then visit San Antonio municipal government, archives, or libraries to search related documents or recordings to obtain data about these projects, use the information to establish models for the San Antonio area, and also use the data they obtain to verify if their models are effective. A report for each project will be conducted for self-reflection. The reports should show more specifically

- where the experiential learning is performed,
- how and what information is gained,
- how the information is used to set up the models,
- what useful extra factors are particularly considered in the San Antonio area,
- how textbook models should be updated to reflect these particular situations,
- whether their models fit the data they obtain,
- how their models can make prediction for future occurrence,
- finally, an overall self-reflection about this community-based learning.

The final oral presentation is used for discussions about the experiential learning, critical thinking, and experience sharing. The instructor will grade the reports and presentations. Feedback will be provided for students to improve their experiential learning performance. Students also use the past project experiences to improve their next experiential learning project.

Grading policy: Final grades will be based on HWs, experiential learning projects, attendance, and the final talk. Ratios are: experiential learning projects 35%, HW 30%, attendance 10%, and final talk 25%.

Grading scale: Use “T” to represent the total weighted point in a 100 scale for a student. The grading scale in a letter grade is $T \geq 90$, A grade; $T \geq 80$, B grade; $T \geq 70$, C grade; $T \geq 60$, D grade; $T < 60$, F grade.

HW extension policy: Missing assignments can only be rescheduled for a later date in case of student illness, family issues, attending University events, or other significant cases approved by the instructor. An official document is required for the excuse. Students have to immediately inform the instructor in person about the circumstances and negotiate the day of the makeup.

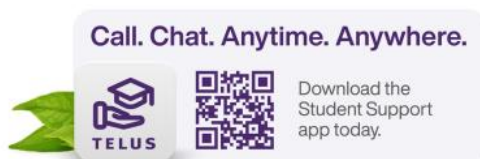

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
