Course Description

Origin and development of the Texas constitution, structure and powers of state and local government, federalism and inter-governmental relations, political participation, the election process, public policy, and the political culture of Texas.

Course Learning Objectives

- Course Learning Objective 1: Students will analyze the origins of the U.S. Constitution and understand how foundational principles such as separation of powers, checks and balances, and sovereignty shape our federal government.
- Course Learning Objective 2: Students will be able to describe the organization, roles, and powers of the legislative, executive, and judicial branches, and evaluate how these institutions interact within each other.
- Course Learning Objective 3: Students will comprehend how individuals and groups engage with politics through voting, political parties, interest groups, and civic action.
- Course Learning Objective 4: Student will gain a deeper understanding of their civic rights and duties within our society, and the importance of participation in the political process.

Student Expectations

Late Assignments

The instructor does not allow late work or submissions.

If you miss an exam, or an assignment, you will not be able to take them and will be given a grade of zero. Make-up exams and late assignments will only be permitted with a valid, documented excuse.

Course Assignments

Exams

Students will be required to take 3 section tests covering all material presented in the course. Each exam will consist of 50 multiple choice questions, based on class lectures and questions from the chapter assignments. Students will be required to take the exam on Blackboard, using LockDown Browser...

If you miss an exam, you will not be permitted to take the exam unless you have a documented excuse.

Writing Prompts

Students will be required to write 6-8 short writing prompts during the semester. The purposes of a writing prompt are to encourage the student's interest in a topic being covered in class and encourage them to write about it in a thoughtful and creative way.

These writing prompts can provide students an opportunity to elaborate and expand on an issue that is being covered in class.

Chapter Assignments

Students will be required to complete 6-chapter assignments for the semester, based on the chapters in the textbook. This assignment will be available at the beginning of the week on the date scheduled, and will be due before 11:59pm, Sunday. Each assignment will consist of 10 questions from the textbook.

Students who miss a chapter assignment will have the opportunity to make up one chapter assignment at the end of the semester, to replace the 0 you received.

McGraw Hill Connect

Beginning Oct 1, Students will be required to complete 6 SmartBook assignments through Connect by the designated deadline.

These activities are designed to improve student comprehension and overall performance. There is no time limit on these assignments, and each student gets unlimited attempts on these assignments.

Technology Issues

Students are responsible for ensuring that assignments are successfully submitted by the designated deadline. If you encounter a tech issue when submitting an assignment, please notify the instructor, along with a screenshot of the error or issue you are experiencing.

Students will not be allowed to use AI software for their writing assignments. Which means students are required to submit their own original work on assignments. Anyone caught using AI (20% or more) for their assignments will be given a grade of (0).

Students should not have another person/entity do the writing of any portion of an assignment for them, which includes hiring a person or a company to write assignments and/or using artificial intelligence (AI) tools like ChatGPT.
