Course Description

- ✚ By focusing on academic expectations, success strategies, and career exploration, this course equips first-year students with the skills needed for a successful transition to university life. Students will learn to access and utilize campus resources, develop self-awareness and personal agency, and practice habits that foster responsibility and engagement. The course also encourages active participation in the campus community as students build a foundation for their academic and personal goals.

Course Promises (Course Learning Outcomes)

- ✚ This course makes a set of promises to you if you fulfill the **Course Expectations** listed below. Course promises with objectives:

1. Exhibit growth in self-awareness, agency, and personal responsibility

Students will achieve this by:

- **Assess** their personal strengths, challenges, and learning preferences.
 - **Demonstrate** personal responsibility by meeting course expectations (e.g., deadlines, attendance, participation) consistently over the term.
 - **Create and revise** a personal action plan that reflects growth in decision-making and ownership of academic success.

Course Expectations

Attend classes! Attendance and Participation (100 Points)

- Attendance and participation are worth 100 points of your **final grade**.
- You will earn points throughout the semester by:
 - **Attending class**
 - **Arriving on time**
 - **Participating in discussions and activities**
 - **Engaging with course content**
- Attendance points **cannot** be made up for unexcused absences.
 - Because much of the learning in this course **occurs through in-class interaction**, students who are absent will also miss opportunities to complete participation activities and earn associated points
- Students **arriving 15 or more minutes late** or leaving early will be **marked absent** from the class session and **will not earn attendance points for that day**.
- **Excessive tardiness (3+)** may result in additional **reductions** to participation points

Excused Absences

- Students are expected to attend all class sessions. An **absence may be considered excused** for the following reasons:
 - University-sponsored activities that require the student's participation
 - Religious days as recognized by university policy
 - Military service obligations
 - Serious illness, medical emergencies, or hospitalization of the student
 - Death or serious illness of an immediate family member
 - Other circumstances required by university policy or approved by the instructor
- Whenever possible, students should **notify the instructor in advance** of an anticipated absence. Documentation may be requested for excused absences
- Excused absences do not result in disciplinary action; however, attendance and participation points associated with missed class sessions generally cannot be earned without completing an alternative assignment.
- The alternative assignment is at the discretion of the FYS faculty member.
 - **While students may encounter circumstances that require them to miss class, accumulating more than four absences for any reason may result in removal from the course.**

- ✚ Assignments provide you with both informal and formal opportunities to articulate your responses to the issues and topics we will discuss.
- You will get the most out of the course if you:
 - Turn in your work on time!
 - It is vital that you follow basic grammar rules to receive full credit for assignments.
 - Regardless of the length of the response, make sure you check grammar and academic writing standards.
 - All responses reflect who you are and are intended to prepare you for academic and professional writing.

Late Work Policy

- ✚ Apart from the final project, you can request an extension on all assignments, which will be based on individual needs at the time of request.
- ✚ Assignments on Blackboard are closed after the due date and must be reopened for late work. This will only happen **at your request, the student**.

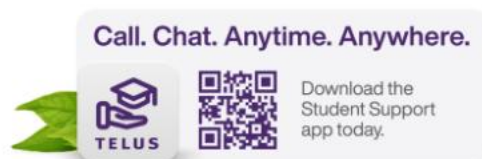

Counseling/Mental Health Resources

Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Jaguar Writing, Language, and Digital Composing Center (WLDCC)

The WLDCC provides support to graduate and undergraduate students in all three colleges as well as faculty and staff. Writing tutors work with students to develop reading skills, prepare oral presentations, and plan, draft, and revise their written assignments. Our language tutors support students enrolled in Spanish courses and students composing in Spanish for any assignment. Our digital studio tutors support students working on digital projects such as eportfolios, class presentations, or other digital multimedia projects

The WLDCC offers face-to-face, synchronous online, and asynchronous digital appointments. Students can schedule appointments with the WLDCC in JagWire under the Student Services tab. Click on "Writing, Language, and Digital Composing Center" to make your appointment. Students wanting to work in realtime with a tutor can schedule an "Online Appointment." Students wishing to receive asynchronous, written feedback from a tutor can schedule an "eTutoring" appointment. More information about what services we

Texas A&M University-San Antonio recognizes the wide variety of faiths represented among the campus community and protects the rights of students, faculty, and staff to observe religious holidays according to their tradition. Under the policy, students are provided with an opportunity to make up any examination, study, or course work requirements that may be missed due to a religious observance provided they notify their instructors before the end of the second week of classes for regular session classes.

The Six-Drop Rule

Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Pregnant/Parenting Students

Texas A&M-San Antonio does not require a pregnant or parenting student, solely because of that status or issues related to that status, to (1) take a leave of absence or withdraw from their degree or certificate program; (2) limit the student's studies; (3) participate in an alternative program; (4) change the student's major, degree, or certificate program; or (5) refrain from joining or cease participating in any course, activity, or program at the University. The university will provide such reasonable accommodations to pregnant students as would be provided to a student with a temporary medical condition that are related to the health and safety of the student and the student's unborn child. These could include maintaining a safe distance from substances, areas, and activities known to be hazardous to pregnant individuals and their unborn child; excused absences because of illness or medical appointments; modified due dates for assignments; rescheduled tests/exams; taking a leave of absence; and being provided access to instructional materials and video recordings of lectures for excused absences, if these would be provided to any other student with an excused absence. Students' Rights and Responsibilities

The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. This philosophy acknowledges the existence of both rights and responsibilities, which is inherent to an individual not only as a student at Texas A&M University-San Antonio but also as a citizen of this country.

Students' Rights

1. A student shall have the right to participate in a free exchange of ideas, and there shall be no University rule or administrative rule that in any way abridges the rights of freedom of speech, expression, petition, and peaceful assembly as set forth in the U.S. Constitution.
2. Each student shall have the right to participate in all areas and activities of the University, free from any form of discrimination, including harassment, on the basis of race, color, national or ethnic origin, religion, sex, disability, age, and pregnancy/parenting or veteran status in accordance with applicable federal and state laws.
3. A student has the right to personal privacy except as otherwise provided by law, and this will be observed by students and University authorities alike.
4. Each student subject to disciplinary action arising from violations of university student rules shall be assured a fundamentally fair process.

Students' Responsibilities

1. A student has the responsibility to respect the rights and property of others, including other students, the faculty, and administration.
2. A student has the responsibility to be fully acquainted with the published University Student Rules found in the Student Handbook, [Student Code of Conduct](#), on our website, and University Catalog, and to comply with them, as well as with federal, state, and local laws.
3. A student has the responsibility to recognize that student actions reflect upon the individuals involved and upon the entire University community.
4. A student has the responsibility to recognize the University's obligation to provide a safe environment for learning.
5. A student has the responsibility to check their university email for any updates or official university notifications.

Artificial Intelligence Policy

In such cases, no more than 25% of the student's work should be generated by AI. If any part of this is confusing or uncertain, students should reach out to their instructor for clarification before submitting work for grading. Use of AI-generated content without the instructor's permission and/or proper attribution in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.
