COURSE DESCRIPTION

Integrated Reading & Writing (INRW) improves your college-level reading comprehension and writing effectiveness. You will learn critical reading and writing strategies to communicate persuasively while considering audience and purpose. You will respond in written and oral discussion to a variety of texts across disciplines and genres, including academic texts to prepare you for future coursework.

Course Goals

- activate prior knowledge to help articulate your identity as a reader and writer
- approach writing as an act of self-expression, creativity, and critical thought
- approach reading as an act of interpretation involving intersectional lenses
- understand different forms of reading (academic, rhetorical, entertainment)
- engage in the reciprocal relationship between reading and writing
- transfer our reading and writing knowledge across genres
- examine the ethical responsibilities of readers and writers

Instructor Commitments

- honor your knowledge and draw upon our community's knowledge
- teach reading as a conversation between author and audience
- teach writing as a way to examine what and why we read

Student Commitments

- exercise integrity and care in your work and in interactions with others
- read the syllabus and calendar and know when assignments are due
- professionally communicate with me when you need assistance

- All readings will be Open Educational Resources available via Blackboard.
- A notebook—studies show handwritten notes result in greater retention of course material.

GRADING OVERVIEW

I use a labor-based approach to grading. Labor-based grading assesses you on the quality of your labor. Your grade in this course depends on the amount of work you submit, your ability to meet deadlines and fulfill expectations, and the time and effort you put toward achieving goals. I will also address the quality of your work. You will put forward the time and effort it takes to improve your reading and writing skills, and you will demonstrate significant growth as a reader and writer over the course of the semester. I am committed to affirming linguistic diversity in reading and writing approaches.

<u>Financial Aid and Verification of Attendance</u>: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended the first week of class. Writing, Language, and Digital Composing Center: The Writing, Language, and Digital Composing Center supports graduate and undergraduate students in all three colleges as well as faculty and staff. Tutors work with students to develop reading skills, prepare oral presentations, and plan, draft, and revise their written assignments. Our language tutors support students enrolled in Spanish courses and students composing in Spanish for any assignment. Our digital studio tutors support students working on digital projects such as

A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

AI Policy: The FYC program expects you to generate your own content this semester. However, there are situations and contexts within our courses where you may use generative artificial intelligence (GAI) tools to support your work as a writer. For example, GAI technologies such as ChatGPT can work well as a starting point for written assignments, assisting you with brainstorming, outlining, generating ideas, and collecting basic information about a topic/idea. Note that the emphasis here is on "support." GAI programs have been shown to provide biased information, to circulate misinformation, and to generate writing that is, at best, mediocre. For these reasons, FYC discourages you from using GAI technology to generate content for you. If you have reason to use GAI to generate content with you, then we ask that you consult with your professor before doing so. If your professor approves your use, you should acknowledge the GAI program you have used, and you should identify which portions of the text you submit were produced by GAI. Using GAI content without your professor's permission and/or without proper attribution qualifies as plagiarism.
