COURSE DESCRIPTION

This course builds on the writing skills you developed in ENGL 1301 and invites you to enter into academic discourse through research. You will synthesize and respond to a variety of perspectives on a topic of your choosing. You will also read and compose a variety of texts. This course is part of the First-Year Composition (FYC) Program, which supports your ongoing growth as a writer and prepares you to use your writing to contribute in academic, civic, and professional contexts.

Structure and Assignments

ENGL 1302 features three units, each focused on a different type of writing. Unit 1 focuses on rhetorical analysis, argumentative writing, and thesis statements. This unit is reading intensive and features excerpts from graphic novels, poetry, philosophy, and nonfiction essays. There will be several small writing assignments accompanied by a formative essay, the rhetorical analysis. Finally, you will learn how to draft working research questions and thesis statements in preparation for your research project, and publish to Digication your **Rhetorical Analysis** alongside your **Unit 1 Reflection**.

Unit 2 is devoted to the invention, drafting, workshopping, and publishing of a research project focused on the historical significance of the San Antonio Missions National Historical Park. Readings include scholarly database research, poetry, and investigative journalism. Moving through the research process, you will propose a topic, conduct database research, write an annotated bibliography, draft your research essay, provide peer feedback in a writing workshop, edit and revise your essay, and publish your **Research Essay** in Digication alongside your **Unit 2 Reflection**.

Unit 3 focuses on professional writing and reflection. You will research and write a media review, career profile, resume, cover letter, and two reflections. In the final weeks of the semester, you will attend a final exam review, final individual conference, and the final examination. You will publish to Digication your **Unit 3 Reflection** and **Final Reflection** as part of your Writer's Portfolio.

Required Materials

- All readings will be Open Educational Resources available on Blackboard.
- Digication—you will add to your Writer's Portfolio and compose a final reflection.
- A notebook—studies show handwritten notes result in greater retention of course material.

Learning Community

This course is paired with HIST 1302-019 in a learning community. As part of this course, we will conduct primary and secondary research on the San Antonio Missions National Historical Park and take a trip. A follow-up reflection assignment will count towards your grade in both course.

GRADING OVERVIEW

I use a labor-based approach to grading. Labor-based grading assesses you on the quality of your labor. Your grade in this course depends on the amount of work you submit, your ability to meet deadlines and fulfill expectations, and the time and effort you put toward achieving goals. I will also address the quality of your work. You will put forward the time and effort it takes to improve your writing skills, and you will demonstrate significant growth as a writer over the course of the semester.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. AI Policy: The FYC program expects you to generate your own content this semester. However, there are situations and contexts within our courses where you may use generative artificial intelligence (GAI) tools to support your work as a writer. For example, GAI technologies such as ChatGPT can work well as a starting point for written assignments, assisting you with brainstorming, outlining, generating ideas, and collecting basic information about a topic/idea. Note that the emphasis here is on “support.” GAI programs have been shown to provide biased information, to circulate misinformation, and to generate writing that is, at best, mediocre. For these reasons, FYC discourages you from using GAI technology to generate content for you. If you have reason to use GAI to generate content with you, then we ask that you consult with your professor before doing so. If your professor approves your use, you should acknowledge the GAI program you have used, and you should identify which portions of the text you submit were produced by GAI. Using GAI content without your professor’s permission and/or without proper attribution qualifies as plagiarism.
