## **Course Description**

This course provides a solid background in ecology and introduces the student to the scientific study of organisms and their environment. We will address the basic abiotic and biotic components involved in the function and evolution of ecosystems, different ecological models, and the mechanisms that drive ecosystem changes through time. The course will incorporate the classic concepts of ecology and will introduce the students into current theoretical and applied aspects of ecology, from a global scale to the organismal level.

### **Course Objectives**

- 1. Develop and appreciation of past and modern scope of scientific inquiry in the field of Ecology, through lectures and assignments.
- 2. Understand the mechanisms behind the interaction between organisms (from bacteria to plants and animals) and their environment.
- 3. Understand how scientists' conduct studies in ecology, including techniques, methods and equipment used to address different ecological questions.
- 4. Learn about the many theoretical and applied aspects of ecology at a global scale and in Southern Texas, particularly Bexar County.
- 5. Understand the importance of ecology as a tool to study current environmental issues.
- 6. Provide a clear understanding of the effect that ecological processes have on our daily lives and all living system in our planet.
