Course Description:

This course is designed to expose students to a wide range of topics, ideas, and perspectives through a series of engaging talks and presentations. In this seminar class, students will have the unique opportunity to broaden their horizons, challenge their preconceptions, and cultivate critical thinking skills by attending a diverse array of guest lectures each week.

Course Objectives:

Exposure to Diversity: Gain exposure to a broad spectrum of topics, industries, and intellectual fields through weekly guest speakers.

Critical Thinking: Develop critical thinking and analytical skills by engaging with complex and multidisciplinary ideas presented by experts.

Interdisciplinary Exploration: Foster an appreciation for interdisciplinary connections and the interplay between various fields of knowledge.

Networking: Build connections with guest speakers and fellow students who share a passion for intellectual curiosity.

Communication Skills: Improve listening skills, as well as the ability to engage in meaningful discussions during Q&A sessions.

Grade:

Attendance ($10 \times 10 = 100 \text{ points}$): Your consistent presence at seminars is vital for your engagement and learning experience. You are required to attend at least 10 out of the 12 scheduled speakers, earning you a total of 100 points. There will be a sign-in sheet.

Seminar Summaries ($10 \times 10 = 100$ points): To demonstrate your comprehension and engagement with the material, you will write concise summaries for a minimum of 10 seminars. Each summary is worth 10 points, totaling 100 points. You will submit this as a single document at the end of the semester.

Introduction of Speaker (1 x 50 = 50 points): You will have the opportunity to introduce one of our guest speakers during the course of the series. The date will be randomly assigned to you. This exercise will enhance your public speaking skills and is worth 50 points.

Final Reflective Essay (1 x 50 = 50 points): Your final assignment will be a reflective essay where you share your insights and personal growth stemming from the seminar series. This essay should explore both the scholarship presented and the speaking styles of the speakers. This assignment carries a weight of 50 points.

Total Possible Points: 300

I encourage active participation, thoughtful engagement, and reflection throughout the semester.

<u>Financial Aid and Verification of Attendance:</u> According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended the first week of class. Any student receiving federal financial aid who does not attend the first week of class will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Students' Rights

- 2. Students' Responsibilities

1. A student has the responsibility to respect the rights and property of others, including other students, the faculty and administration.

- 3. A student has the responsibility to recognize that student actions reflect upon the individuals involved and upon the entire University community.
