Course Description

This course will introduce the student to plant classification using a Systematics (evolutionary origin and relation of plant groups) and Taxonomic (naming plants based hierarchical and categorical criteria) approach. The course mainly focuses on vascular and more specifically flowering plants, an important group that dominates most of Earth's terrestrial ecosystems and has provided many services to humans and many other life forms throughout our planet's history. During the course, students will be introduced to concepts and the construction of plant phylogenies, the diversification and evolution of plant species, and will be provided with an overview of important features used to identify and differentiate vascular plants. Students will develop an understanding of the phylogenetic arrangement of plant groups **from around the world**, and the main structural and biochemical characteristics, evolution, economic value, and ecological value for each group.

Course Objectives

- 1. Understand the mechanisms that explain the diversity of plants and how plants have adapted to different environments.
- 2. Understand differences among plants from a chemical, molecular, cellular, morphological, and ecological perspective.
- 3. Understand the links between plant uses, plant products and both the economic and ecological value of each group.
- 4. Read and evaluate original literature (including peer reviewed journals) to gain direct access to historical and modern developments in the field of Plant taxonomy and systematics.
- 5. Learn to appreciate plant diversity and the different roles that plants have played and could play in the life of humans.
- 6. Plan and execute a plant related project throughout the semester that will help enhance your understanding of plant diversity, morphology, function, and importance.

Course Evaluation



Exams: First half of the Exam will be taken individually using a scantron and will include multiple choice, true/false questions. Second half of the Exam will include short answers, and essay type questions. Exams will take place on the Tuesday of Exam week. (See schedule)

- Exams are closed book, and most questions will come from or will be like the quiz questions.
- The Exam my include figures, tables, diagrams or articles that will be provided the day of the Exam
- Each exam will include the material covered up until the week prior to the day of the exam.
- You will have 30 minutes to complete the first half and 45 minutes to complete the second half. If all group members complete the first part before the 30 minutes the group may start the second half.
- The exam will include 20-25 multiple choice questions that will be answered individually using a scantron and 2-3 short answer questions that will be answered as a group.

Quizzes: Quizzes will be available weekly

- Regular quizzes will be available via blackboard and completed outside of lecture time. You will have <u>5 days to complete the quiz and submitted before the Due date and time</u>.
- However, on the week of Exam a quiz will be submitted on Wednesday and you will have 48 hours to complete and submit before the end of the day
- Your quiz can be taken <u>three times</u>, and the highest score will be added to your gradebook.
- Questions will be presented one at a time and no backtracking will be possible; the number of questions may range from <u>5-10 questions</u>.
- Length of quiz may range from <u>5 to 10 minutes.</u>

Assignments: This may include a scientific article summary and critiques or in class activities

- Please read instructions provided on how to write an article summary and critique.
- Depending on the assignment, submission may be during lecture or after lecture.
- Most assignment in class will be conducted as a group. So only one draft per group will need to be submitted. If you are absent, you may not make up the assignment unless you provide a reasonable excuse for your absence.
