#### **Course description**

This course (CHEM 4101) is the co-requisite laboratory for Physical Chemistry I (CHEM 4301) and complements the concepts introduced in the lectures. This lab is emphasized on designing and executing experiments facilitating team-oriented critical thinking and problem solving. Knowledge acquired with investigating the relationship between theory and experiment, analyzing data and writing professional report also mirrors the team-oriented problem solving in professional laboratories.

#### **Practical implications**

- Developing a feel for designing and executing experiments selecting the optimum equipment or operation in a team environment
- Developing a logic for relationship between theory and experiment
- Keeping a laboratory notebook as a record of what is done and why it is important
- Design a student project, support with the collected experimental data and present
- Analyzing physical properties of materials using modern instruments and complement with the computational data
- Analysis of experimental data using statistical analysis
- Writing professional report
- Comparing the experimental results with available published journal article(s)
- The value and limitations of computational methods

## **Course Materials**

<u>Financial Aid and Verification of Attendance:</u> According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. **AI policy** CHEM2323-001 assumes that all work submitted by students will be generated by the students themselves, working individually or in groups. Students should not have another person/entity do the writing of any portion of an assignment for them, which includes hiring a person or a company to write assignments and/or using artificial intelligence (AI) tools like ChatGPT. Use of any AI-generated content in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

Attendance Policy. All students are expected to attend all laboratories and be fully and actively engaged in lab activities. Attendance will be monitored. Absences will be excused if due to illness (medical excuse), death of a close family member, religious holiday (please inform instructor), official university activity, cancellation of classes/closure of the University, military duties, pregnancy & related conditions, or participation in legal proceedings. Only one laboratory will be excused for the above reasons.

**Be prompt.** TARDINESS WILL NOT BE TOLERATED. A point from your experiment grade will be deducted for every minute you are late, up to 20 minutes. After 20 minutes, you will not be allowed to perform the experiment. Pre-lab lecture and lab attendance will be recorded at the beginning of each meeting.

Late Work Policy. Students will be informed about due dates and times for laboratory reports. Work is required to be turned in on time. Late work will be subjected to an additional 25% penalty per day. For example, if a report is due Friday at 11:59pm and the student submits the report on Saturday at 8am, 25% will be deducted. If the report is submitted on Sunday, 50% will be deducted. Late lab work that is more than three days late will not be accepted.

Lab Partners. Students will work with a partner. We have made every effort to ensure that an even number of students are enrolled in this class. Therefore, barring extenuating circumstances, only groups of two students are permissible. Each group of two is expected to work independently and not with neighboring groups.

Lab partners may be randomly assigned by the instructor and may be changed at any time on a rotating basis.

Visitors. Only students enrolled in the course are allowed in the class. No visitors are allowed.
