Course Description

This course will introduce you to research methods used in criminology and criminal justice. We will explore the nature of scientific inquiry, issues in research methods, research designs, and statistical concepts used in quantitative analyses. By the end of the course, you should be able to understand various research methods used to study criminology, including how to critically review criminological research, know how to interpret specific statistics, and how to recognize strengths and weaknesses of research designs.

Student learning Objectives/Outcomes

By the conclusion of the course, students will have the opportunity to understand and critically assess issues related to:

- Be able to describe and identify important methodological procedures required to perform quantitative and qualitative criminological, sociological, and public affairs research.
 - Be able to differentiate between such research components as: types of research designs, levels of measurement, and types of variables.
 - Be able to critique the measurement issues in journal articles reporting research on a substantive social science topic.
 - Prepare a literature review related to an approved substantive social science topic.

Course Requirements

Discussion Board Post/Reply: Throughout the course, you are required to post a response to various prompts on the discussion board section of Blackboard. Each prompt/question of the post must be at least 8-10 sentences in length (1-2 paragraphs) and should directly relate weekly material and cite sources accordingly. The post will be assessed on completeness, correctness, and quality of writing.

Further, each week you must respond to at least 1 classmate with substantive contributions, e.g. you must respond with additional information, offer a different perspective regarding the author's (classmate's) position, etc. Simply agreeing or offering congratulatory remarks ("Good post") are not sufficient and unnecessary. Each response must be 4-5 sentences in length (1 short paragraph). What you contribute with a response will vary – some weeks you'll be participating in a research-related component of a post (e.g. answering survey questions) and other weeks you may be simply providing feedback (e.g. helping to improve survey questions).

Examinations: There will be three closed-book exams administered throughout the semester (inclusive of the Final Exam). The exams cover the assigned readings, notes, videos and any additional materials presented or provided. Additional information regarding the format, structure, and specific material will be provided in advance.

No student will be permitted to make up a missed exam unless sufficient documentation is provided. This must be discussed with the Professor

Literature Review: Students will be required to complete a Literature Review consisting of multiple parts – each to be completed throughout the semester. Guidelines for these assignments will be discussed and distributed via Blackboard.
