# HIST 3301: Reading & Writing Like an Historian Spring 2024

#### **COURSE DESCRIPTION:**

This course provides students with an overview of the paradigms and approaches that guide research and writing about the historical past. It also surveys important historiographical traditions and trends. The goal is for students to understand how historians approach the profession, both intellectually (what is "history" and why do we study it) as well as practically (what are the different approaches to historical writing). We will be covering a variety of historical genres, including social, cultural, gender, environmental, colonial, postcolonial, etc.

#### **LEARNING OUTCOMES:**

At the end of this course, the student will be able to:

- 1. assess the historiography of a subject;
- 2. analyze and interpret secondary sources; and
- 3. understand differing approaches to the study of history.

#### **ASSIGNMENTS:**

#### **Attendance Policy** (10%):

Students are expected to attend classes in person each week (see Course Calendar below, pp. 7-9, for Class Meeting dates). If you know in advance that you will miss a scheduled class meeting, please notify me immediately so that you will not be marked absent. More than **three unexcused absences** from class meetings will result in a drop of one letter grade from your overall final grade for the course or an "F" for more than seven unexcused absences.

#### Weekly Readings, Quizzes, Discussion (25%):

Students will submit low-stakes written assignments via Blackboard (Bb) and take quizzes in class based off the assigned readings, discussion, film, primary and secondary source analysis. You will be graded on the quality of your contributions and your ability to analyze, think critically, and discuss course concepts. *Note:* Points will be subtracted from your final score for being turned in past the due date and the same applies to all high-stakes assignments during the semester described below.

#### **Annotated Bibliography (10%):**

The annotated bibliography will help you with writing your historiographical essay, which examines what historians have argued about a particular topic that you will choose based upon your own interests. Include anywhere from five-to-eight secondary sources (books/articles) and briefly discuss (annotate) each source: 1) describe the source; 2) thesis (main argument); and 3) how it will help your historiographical essay. The *Due Date* for your annotated bibliography is *Thursday, March 7* (via Blackboard Message).

#### **Analytical Paper (15%):**

I will provide you with a **Guide** (& **Rubric**) to **Writing the Analytical Paper**. The format for this paper will be three pages in length (or 750 words), typed, double-spaced, and 12-point font (Times New Roman). You will analyze a chapter from Dr. Joaquín Rivaya Martínez's book, *Indigenous Borderlands: Native Agency, Resilience, and Power in the Americas*. The **Due Date** for the Analytical Paper is **Friday, April 26** (by Midnight) via Turnitin in Bb, which checks for plagiarism, including AI (see Academic Misconduct Policy below, page 3).

#### **Historiographical Essay Draft (20%):**

I will provide you with a **Guide (& Rubric) to Writing the Historiograhical Essay**. The format will be eight-to-ten pages in length (or 2,000 to 2,500 words), typed, double-spaced, and 12-point font (Times New Roman). The *Due Date* for this draft is *Thursday, April 11* (by Midnight) via Turnitin in Bb (see Academic Misconduct Policy below, page 3).

#### **Historiographical Essay Final** (20%):

Same format as the draft. Be sure to make corrections based off the edits that I make on your draft. The *Due Date* for this final version is *Tuesday, May 7* (by Midnight) via Turnitin in Bb (see Academic Misconduct Policy below, page 3).
