**Course Overview**

The underlying principles governing political relations among sovereign states and the application of these principles to contemporary international problems.

**Student Learning Outcomes**

1. Demonstrate basic knowledge of major international relations ideas and theories
2. Identify the major issue areas of international relations including the causes of war, international political economy, and international law and organization.
3. Describe how one or more of the theories of international relations explain events in one or more of the major issue areas of international relations.
4. Gain a better understanding of current events and be able to apply basic concepts to contemporary events.

**Course Requirements**

Homework Assignments – There are weekly homework assignments in the course. They will be posted on Blackboard at least one week before the due date. All assignments are due on Blackboard on Sunday at 11:59pm. Each assignment is worth 20 points. I will drop the lowest assignments (200 total points)

Quizzes – There are also weekly quizzes in this course. You can take the quiz on Blackboard and they will be open on Monday at 2pm and are due on Tuesday at 2pm, right before class. Each quiz will cover the chapter covered for that week as well as some questions from previous chapters. Each quiz is worth 20 points (1 point per question). I will drop the lowest quizzes (200 total points)

Exams – There are two exams in this course – a midterm and final exam. The midterm will be worth 100 points and the final will be worth 150 points. Both exams will be a combination of multiple choice and short answer. (250 total points)

Participation - A combination of in class activities and contributions to class discussion. (100 total points)

### **Attendance Policy**

This course is hybrid meaning half the class will be conducted in person and half will be online. Students are expected to attend all in person sections of the class. If a student is unable to attend the in class portion, they must notify me as soon as possible. The online portion of the class will be conducted asynchronously so there is not an attendance requirement for the part of the class, but there will be weekly assignments that are required for the students to complete before we meet in person on Thursdays so students must “attend” to those assignments each week.

### **Electronics Policy**

Students can use laptops and/or tablets in class if they feel they are helpful for their educational experience. However, as the instructor I reserve the right to tell students to stop using them if I feel they are causing a distraction to myself or the rest of the class. I prefer that student put their phones away for the duration of the in person portion of the class.

### **Make-Up Assignments**

I will accept late homework assignments for up to 1 week after the due date. Additionally, I will not extend the due dates for assignments. I will not allow make up quizzes or exams except in extreme circumstances.

### **Penalties for Academic Dishonesty**

### Financial Aid and Verification of Attendance:

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
