## **Course Description and Materials**

**Catalog Description:** This course covers many topics in mathematics which are important in computer science. Some of these topics are sets, relations, functions, algorithms, graphs, monoids, lattices, Boolean algebras, and graphs.

**Prerequisite:** MATH 3320, MATH 3325, MATH 3340, or MATH 3415; all prerequisites require a grade of "C" or higher.

**Required Textbook:** Discrete Mathematics and Its Applications by Kenneth Rosen (the 8<sup>th</sup> edition), McGraw-Hill with ISBN-13: 978-1-259-67651-2.

Student Learner Objectives: Upon the completion of this course, students will be able to:

- 1. Become familiar with key concepts and techniques in discrete mathematics.
- 2. Be able to formulate and solve problems requiring the application of discrete mathematics.
- 3. Develop a basic proficiency in explaining and interpreting discrete mathematical concepts in a variety of mathematical subject areas.

List of Topics: Topics to be covered include but are not limited to the following:

- 1. The foundations of propositional logic (Sections  $1-1 \sim 1-3$ ).
- 2. Predicates and quantifiers, and nested quantifiers (Sections  $1-4 \sim 1-5$ ).
- 3. Rules of inference, and proof methods and strategy (Sections  $1-6 \sim 1-8$ ).
- 4. Boolean Algebra (Sections 12-1 ~ 12-4).
- 5. Sets and set operations, and functions and their properties (Sections  $2-1 \sim 2-3$ ).
- 6. Sequences and summations, and cardinality of sets (Sections  $2-4 \sim 2-5$ ).
- 7. Algorithms (Sections  $3-1 \sim 3-3$ ).
- 8. Number theory (Sections  $4-1 \sim 4-4$ ).
- 9. Cryptography (Sections 4-5 ~ 4-6).
- 10. Induction, recursion, and fractals (Sections 5-1 ~ 5-3).
- 11. Basic counting techniques (Sections  $6-1 \sim 6-5$ ).
- 12. Advanced counting techniques (Sections 8-1 ~ 8-2).

The instructor reserves the right to modify/update the topics as appropriate.

**Inquiry-Based Active Learning:** This course implements inquiry-based active learning approaches throughout, and thus the students are strongly encouraged to preview the teaching materials and be aware of many class-participation and self/peer study activities.

**NOTE.** This class meets three times a week. Aside from the three hours that you spend in class each week, you should devote at least another 4~6 hours to studying on your own: reading the book and my lecture notes, working out your homework assignments, and solving some extra related problems for practice etc. You are responsible for any and all materials/topics discussed in this class.

# **Course Expectations and Requirements**

**Examinations:** There will be three midterm tests during the semester and one comprehensive final exam in the end (scheduled during the Finals Week).

Students will take all examinations at regularly scheduled times. Exceptions for a legitimate reason may be granted and must be approved in advance by your instructor. Students should notify, or under certain unusual circumstances have other(s) to notify, the instructor formally that you will miss, or have missed an exam, and provide a reason with accompanying documents supporting that, for your absence within 24hrs of the scheduled exam date. Your instructor can be notified via e-mail with a written notice. Contact beforehand your instructor to make necessary arrangement, if you know in advance that you will be unable to take an exam at the regular class time. Students who fail to follow the prescribed procedure will receive a **GRADE OF ZERO** on the missed exam.

Examples of valid documented excuses are sickness documented with a doctor's note, death in the family documented with a copy of the death notice, attending university-sponsored events with a Dean's excuse, etc. Minor illness, or attending sports events and like kind (without a Dean's excuse) are not examples of emergency situations.

Test 1 covers Chapters 1 and 12 (only selected important topics). Test 2 covers Chapters 2 and 3 (only selected important topics). Test 3 covers Chapters 4 and 5 (only selected important topics). Final exam covers Chapters 1~6, 8, and 12 (only selected important topics).

**NOTE.** The schedules will be announced at least a week ahead of time in class, in Blackboard, and through emails. The tests/exam will be taken completely in class. Calculators (except for scientific non-graphing, non-programmable calculators), cell phones, laptops, i-pads, kindles, and any other electronic devices are absolutely **NOT** allowed during the tests/final exam. Once found, the tests/final exam would receive a **GRADE OF ZERO**, and if this happened in a recursive manner, the instructor would report to the university as an academic dishonesty issue.

Assignments: There will be totally four homework assignments of this course that should be submitted on their due dates as indicated in the posting on Blackboard and/or as announced in class by your instructor. Problems are assigned after each section of the book covered, which will be summarized with a HW number posted online to Blackboard - Assignment as well, with its due date specified.

Your homework assignments are collected before the end of that day's class. Late homework can **NOT** be accepted. Should you have to miss that day's class, it is solely your responsibility to have your work turned in either in person or electronically before that class time in order for it to be graded. If you cannot finish all the questions, please try to finish as many problems as possible.

Your work should be legible and done neatly. If the work is not presentable or illegible, you will **NOT** receive credit for it. Please staple the sheets of your assignment together in the upper left corner and please do not use papers torn out of spiral bound notebooks. In the upper right corner of your assignment, you should write your name, the class section number, and assignment number (HW1, ..., HW4).

Discipline yourself to write clear readable solutions - they will be of great value for review. You need to show both your answer and the work leading to it. **NO** credit for merely having the right answers. You can have group/team discussions about homework problems. However, you must write up solutions on your own and truly understand the mathematics/algorithms involved. Be mindful of your academic integrity.

**Presentations/Debates**: Students will be expected to participate in class presentations/debates, emphasizing the most recently covered topics that are related to and complementing HWs.

**Research Project**: Towards the end of the semester, you will be given a book chapter to read and write a research report, along with some other work. This is to expose you first experience to mathematical research.

**Evaluation of Student Performance**: Every student's grade will be based entirely on his/her performance. Students will not compete against one another for grades.
