#### As a writing intensive course, students will

- develop their scientific writing skills by completing summaries of articles
- complete peer-review assignments of each other's work.
- Improve their critical writing skills by critiquing articles
- generate an oral and slide presentation that highlights elements of a chosen article
- learn how to critique information, interpret data and results, and ask the right questions.

## **Catalog Description**

Student-led reviews of current scientific literature and historic significance on topics in integrative biology with critical class analyses. Students will refine their ability to search, read, understand, discuss, and critique the primary scientific literature, both orally and in writing. Prerequisite(s): BIOL 3402 and ENGL 2311 or ENGL 1302 must be completed first.

Note: Modern Biology is an integrative discipline, incorporating elements of Mathematics, Chemistry, Computer Science, and Writing. We expect that you have at least a basic understanding of each of these elements.

#### **Course Content:**

This course is designed as a writing intentional course to give students maximum opportunity to hone their scientific skills by accessing the scientific research literature directly and communicating their understanding of these scientific articles in written form. As such, class periods will include workshops aimed at improving scientific writing as well as student-driven discussions with my role as facilitator. For effective discussion, all students must come prepared for each class by reading the assigned article(s) in sufficient depth to participate knowledgeably. Attendance for the workshops and discussions is highly important and will be a portion of your grade. Active and thoughtful participation in both workshops and discussions is a key component for your grade in this course.

#### **Required Textbooks and Other Course Materials:**

A computer with internet access. You will need to install Hypothes.is

#### **Attendance Policy:**

Synchronous attendance is mandatory, and points will be assessed every class period. Discuss unavoidable absences with Dr. Smyth before missing class.

### Blackboard:

This class uses the learning management system (LMS) Blackboard to administer content and evaluate understanding. I will post links to lecture videos, notes, reading materials (other than your textbook), and digital supplements, and you will submit your work in this LMS.

## **Course Components:**

Workshops: There will be 3 in-class workshops designed to teach aspects of the course required for performance assessment. Some workshops have out-of-class assignments associated with them (see below). However, the workshop must be attended to be eligible to submit a work assignment to reflect your learning of the workshop topic. These workshops cannot be made up.

Discussions: You will be responsible for leading one discussion based on one journal article you have selected. You will submit your first choice article and two backup articles as PDFs, so that an alternate article is available in cases of inappropriate first choices. The article will be posted on the course website a week before the discussion for your classmates to give them a week to read it. You will lead the discussion for ½ of the class period. The order of discussions will be randomly assigned using a random number generator.

Preparation for the Discussion: You will submit annotations of each of the articles containing written questions and comments before the discussion via Hypothes.is. This annotation will both prepare you for the discussion and provide evidence of your preparation. If there are terms or other things you do not understand in the paper, be sure to look them up and include them in the annotation, but questions make the best preparation for discussion and increase your performance score. You may annotate the paper by writing directly in the margins of the PDF, alternately you can write your annotations in a text file. In your annotation include two questions or thoughtful comments you had about each article. A link to hypothes.is containing your annotations must be submitted before the discussion.

Relative Contribution to the Discussion: In recognition of potential learning by listening to the discussion, and providing an audience, you will earn 10 points for each pair of discussions that you attend and participate in (there are 2 discussions per class period) resulting in a total of 100 points. The other 90 points will be earned by thoughtfully participating 3 times during the discussions. This participation can include asking a good question, or making a supportive or critical comment about the paper being discussed, or mentioning outside material that adds to the discussion. I will be keeping a checklist each class period to keep track of your participation effort.

Journal Article Critiques: You will write three papers that analyze scientific journal articles. The workshops will guide you in how to write these.

Grading:

- Article Summaries: 20 points (3) = 60 points
- Pre-Discussion Annotations: 20 points (10) = 200 points
- Pre-Discussion Questions: 20 points (10) = 200 points
- Discussion Attendance: 10 points (10) = 100 points
- Contributions to Discussion: 30 points (3) = 90 points
- Written Critique: 150 points (3) = 450 points
- Discussion Leader: 400 points (1) = 400 points
