Course Description: Theory and phenomena of social psychology.

The nature and type of social variables and the methods used to study them. The effect of social variables on individuals. Prerequisite: PSYC 2301

This course may be used as an advanced elective for psychology majors and minors.

Student Learner Outcomes

Students who successfully complete the course will demonstrate:

1. An understanding of the nature of the relationship between situational and individual factors on human behavior;
2. An understanding of the major ways in which social psychology and sociology differ from one another;
3. An understanding of the research methods commonly used by social psychologists;
4. An understanding of the concept of “self” and related concepts (i.e., self-esteem, self-concept);
5. Identify examples of social psychological phenomena.

Assessment of Student Learner Outcomes

The student learner outcomes 1 through 5 above will be assessed through students' performance on the unit exams and the final examination. The paper/presentation and seminar discussions will assess outcomes 3 and 5.

Assignments:

1. **Self-Introduction:** There will be (1) self-introduction, which will allow students the opportunity to highlight some of their best qualities and communication skills with other classmates and the instructor. = (50 points).
2. **Exams:** There will be (3) unit exams (50- questions) each= (150 points) and (1) comprehensive final exam (100 questions) = (100 points) taken this semester. If a student misses an exam, there are **NO MAKE-UP EXAMS**. The exams are online and will be opened one week in advance of the due date, to give students enough time to take them. **The exams are open book.**

3. **Current Events:** There will be (4) (150–250-word count) current events topic that will help students gain a better understanding of the news today (50 points each) = (200 points)

4. **Self-Reflection Essay:** There will be (1) (1-page) brief self-reflection essay. Allows students to reflect on how they see things going on at Texas A&M University-San Antonio, and how they've gotten from point A to point B. = (100 points)
5. **Discussion:** There will be (4) discussions among classmates. This will give you an opportunity to talk about various topics as they relate to scientific research. (50 points each) =200 points
6. **Social Psychology Project: Gender Role Stereotyping:** There will be (1) short (3-page) individual project related to gender role stereotyping. =200 points

From an early age, we learn the differences between how males and females are supposed to behave. Even if you don't break a social norm, you might refrain from engaging in a certain behavior because of your own personal standards. This assignment requires you to look at how level of comfort affects your behavior.

Part 1: Take this test:

Note: this is a dating site but you don't have to register or create a screen name. You can use other sites with the Bem Sex Role Inventory but they are hand scored.

*What do you think of the nature of the questions> Do they imply that there are traits that are masculine and feminine? Would it make you uncomfortable to answer these questions publicly?

*How did you score? Do you agree or disagree with this assessment?

Part 2: Choose a behavior below and perform it for an hour. Please choose something that you don't normally do. These do not violate social norms, rather they make you uncomfortable as they go against your idea of what someone of your sex would do. Perform that behavior within view of others and **without explanation** until you are done and describe your experiences. If this is not an abnormal behavior by society's standards, what part of it made you uncomfortable.

Males:

Carry a purse

Use the words "adorable" and "sooo cute" in your vocabulary

Shop, and have a box of tampons or sanitary pads in your cart (you don't need to buy it, put it back)

Sit and cross your legs at the knee

Ask several people if your outfit makes you look fat

Females:

Wear a fanny pack
Don't wear makeup to class
sit with your legs crossed from ankle to knee or in a very unfeminine fashion
wear a baseball cap, backwards.
Don't shave your legs or armpits and have them exposed.
Reduce your smiling by 50%

Part 3: Sum up your experiences and discuss ways that you have learned these roles? Do you think this is something you want to change? Do you think you would be a better person if you were more masculine? More feminine?

This project paper is worth 200 points reserved for following requirements below:

Requirements:

- Paper must be double-spaced.
- You must use 12-point Times New Roman font and 1-inch margins.
- Make a title page consistent with APA Style, 7th edition. Title of paper and name of student goes on title page only. Do not repeat name, etc. on the first page of text.
- There is a workshop on APA style in the library libguides if you are not familiar.
- Make sure you have a Reference page (as needed) that includes sources you are using.
- Make headers and page numbers consistent with APA Style, 7th edition (on reserve in the library).
- Submit paper in Blackboard (No PDF), Word Document only.
- Proofread your paper before you turn it in. Watch for misspellings and for consistency of tense, pronouns, etc. Example: If you discuss a person in the *singular*, don't refer to that person as "they" later. (APA 7th Edition) may change the use of the pronoun "they"—if it does, I'll let you know.
- **If you use a source... Don't use direct quotations.** I need to see that you can summarize and analyze the material yourself.
- **If you summarize someone else's work, it does NOT involve you changing two or more words in the sentence.** The entire sentence is written in your own words. Not using direct quotations does NOT mean writing the author's sentence word for word and just leaving out quotation marks. Both of those still constitute plagiarism, which is taking credit for someone else's work.

Course Grades:

Each student's grade will be based solely on his/her performance. Students will not compete against one another for grades (i.e., the instructor will not limit the number of As, Bs, etc.). An individual's course grade is based on his or her raw score points (i.e., the total number of points earned during the semester). For example, using the table below, a student who earns 900 points during the semester will earn a "A." A student who has a total of 800 points at the end of the semester will earn a "B" in the course.

Class Participation:

Very few students who miss a lot of coursework perform well in the course. Since you are paying a lot of money per class period, it is to your advantage to login daily. I do include participation in my grading system for final grade points at the end of semester, because class participation depends on meeting deadlines for submitting required assignments on time. Students who login every class day and participate in all required assignments will receive extra credit. You might find it advantageous to drop the class and retake it if you miss several required assignments. You need to take responsibility for your missed work FIRST, then contact me for help if you still need it. I will be VERY willing to help you when you show me that you have put some prior effort into the missed material. This is for your benefit too--if you have worked with the material already, my help sessions will be much more useful to you.

Make-Up or Late Work:

Assignments which are turned in on time must be turned in on the date which it is due unless I have specified another time. Each day the assignment is late, **(ten) points** will be taken off the grade for the assignment. For example, if a student turns in a perfect assignment two days late, the grade for the assignment will be 80. There are **NO** makeup exams. As they are online. Exams will open a week in advance of the due date, giving you enough time to complete them.

***If you are in the hospital, you must email me **BEFORE** the exam. Notifying me beforehand does not guarantee you will be able to make it up, but your request will be heard. If you are leaving town on a planned trip, take it before you leave. ***

There are **NO** exceptions for computer malfunction, if you understand your home computer is not working properly, take your exams and final at the university. This is an online course. Make sure your computer is in its very best working order at all times during the semester. At **NO** time will I hear about your computer problems.

Other Classroom Policies:

Please be respectful of others. Be very careful what you communicate via online during discussions. What is said does not always stay in the course room.

In preference to emailing me and my response back to you in a timely manner. I usually read and respond to emails twice a day. But my policy/standard is to respond back to you within 24-48 hours.

Keep in mind, every email does not require me to respond to them. Emails are for business purposes (i.e., assignments) only. Sometimes students get luck, and I am online at the time an email comes in, and I respond then, but not always.

Texas A&M University-San Antonio does not require me to respond to your emails on the weekend. For example, if you email on Saturday; I will respond back to you during business hour Monday.
