Online Resources: I will do my best to make course materials available online in a timely fashion. My goal is to have course materials posted prior to or within 24 hours of completion of the class in which the material was covered.

Course Description: This course explores exploratory data analysis, experimental design and common inferential statistical techniques used in biology and environmental science. Emphasis is placed on the applications of these methods and practical considerations associated with their proper use. A major focus of the course is using the R statistical computing environment for methodological implementation and generation of high-quality scientific figures.

Objectives: To provide students with a sound foundation in applied statistical reasoning. Specifically, during the course of and/or upon completing the course students should:

- 1. Deepen their abilities to engage in population-level thinking and appreciate the importance of sampling in drawing inferences about populations
- 2. Become familiar with the basic tenets of sound experimental design
- 3. Develop an understanding of the concepts of statistical error and power
- 4. Become competent with a variety of inferential statistics that are commonly used in biology and environmental science
- 5. Deepen their appreciations for the concept of statistical association and how such associations are quantified
- 6. Learn the principles of model criticism and how to assess whether data meet the assumptions of a variety of statistical tests and modeling approaches
- 7. Develop the ability to choose and defend which statistical procedure among the procedures explored during the course is most appropriate for a particular dataset/experimental design
- 8. Develop basic statistical computing skills, including the ability to make customized publication quality graphics

Exam Format: Exams will be administered in a take-home format. You are free to use any resource (e.g., book, webpages, notes, etc.) you like, except for other people, to answer each question. Exam questions will revolve around deciding which technique(s) to use to analyze a given dataset, providing a justification for any decisions that are made, and producing R code that enables the analysis to be performed in the R Statistical Computing Environment.

Policy on Assignments and Exam Questions Involving Written Communication: The ability to write clearly is a fundamental skill that all educated people, including scientists, should have. While I will not deduct points for grammar and spelling per se, if your writing is muddled to the point that the content of your answer is unclear, you will lose points. While you are always free to ask why points were deducted (after class), subsequent clarification of your answer via verbal conversation will not result in the restoration of deducted points to your grade, as grades must be based upon the answer that was turned in at the time that the assignment was due.

Policy on Grade Appeals: We all make errors, and I'm no different. If you feel that I am in error upon receiving a grade for an exam or assignment, let me know after class, or during an office visit. If your concern warrants further consideration, I may ask you for a written explanation of why you think your answer is correct and/or why my grading is overly harsh. Please note that a request for you to elaborate verbally or in writing does not guarantee that points will be restored to your grade.

Policy on Late Assignments & Making Up Exams: Please complete exams and other assignments by their due dates. Should extenuating circumstances arise that prevent you from taking or turning in an exam at the normal time, I may ask you to present verifiable documentation of the circumstances. In other cases, a penalty of 10% per day late may be imposed at the instructor's discretion. Whenever possible, let me know ahead of time if you are going to be tardy with an exam or assignment.
