#### **COURSE DESCRIPTION:**

This is the capstone course for the Masters of Professional Accountancy (MPA) program. The course requires students to integrate, extend, analyze, and apply knowledge gained in the MPA program to demonstrate mastery of the accounting discipline. The course uses a thematic approach that focuses on internal and external reporting issues and choices in accounting policy at the macro and micro levels. Concepts from cost/managerial accounting, accounting information systems, auditing, and taxation will be applied. Course must be taken during in the last semester with the approval of graduate advisor.

Corequisites: BUAD 5135.

Restrictions: Enrollment is limited to Graduate level students.

#### **COURSE OBJECTIVE:**

This course is a rigorous examination of current issues in GAAP, the profession of accounting, opportunities for graduates, and the many certificates available for graduates. This course is NOT a prep course intended to facilitate passing any specific accounting credential exam.

### **STUDENT LEARNING OUTCOMES:**

At the conclusion of this course, you will be able to:

- 1. explain how accounting information is valuable for investment and management decision making;
- 2. explain how the profession of accounting is changing, its challenges and opportunities;
- 3. evaluate current ethical and regulatory issues in accounting;

- 4. use the Codification of Accounting Standards;
- 5. use computer resources to conduct research into accounting and auditing issues.

#### **Required Materials:**

**TEXT:** There is not a specific textbook for this course. You will download and use various authoritative sources of accounting, audit, tax, and business theory and practice.

### WHAT YOU MUST DO TO SUCCEED IN THIS COURSE:

The course is intensive and challenging and you are expected to master the materials presented in class. The structure of the class makes your individual study and preparation outside of class extremely important. Reading the assigned chapter(s) and having some familiarity with them before class will be very useful for understanding lectures.

- Blackboard: Connect to http://tamusa.blackboard.com. You will have lecture notes, solutions to problems, multimedia materials and other supplementary materials in Blackboard. All class communications will be through Blackboard and students should monitor this several times a day.
- There are weekly on-line units of learning posted to Blackboard. Students MUST complete the assigned course requirements on Blackboard prior to each class meeting. You will be held accountable for all materials posted on Blackboard.
- Software: You will be required to use Microsoft Word and Microsoft Excel. You will also use the graphical interfaces for LEXIS/NEXIS, Checkpoint, the Accounting Codification, and EDGAR. These interfaces are webbased and will be accessed through a web browser.
- Computer Hardware: In order to participate in the tutoring sessions (if offered) you will need a computer with a reliable high-speed internet connection, a microphone and speakers/headphones.
- Time: You are expected to spend 4-8 hours per week for the course. Based on the background, some student may require more time. Time spent may be longer when assignment/exams are due.

**Other Recommended / Reading Materials:** Additional reading materials are available on the course website as recommended by the instructor.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
