Course Description and Materials

Catalog Description: The course encompasses the study of limits, continuity, and derivatives of algebraic, trigonometric and transcendental functions and related applications to include maximizing or minimizing a function and rate of change problems. The course also introduces the definite integral, the Fundamental Theorem of Calculus and application to calculation of areas. Curve sketching and graphing tools will be utilized in exploring these concepts.

Math 2113 and Math 2313 help students develop Critical Thinking, Communication, and Empirical and Quantitative Skills by focusing on student understanding of the calculus concepts to include recognizing, identifying, solving, analyzing, and explaining appropriately model applicable real-world situations.

Prerequisite: Math 2312 Pre-Calculus with a grade of "C" or higher, or equivalent.

Recommended Textbook: Essential Calculus, Early Transcendentals by James Stewart (2nd edition) with WebAssign. Cengage Publishing with ISBN-13: 978-1-133-11228-0.

Student Learner Objectives: Upon completion of this course, students will be able to:

- Develop solutions for tangent and area problems using the concepts of limits, derivatives, and integrals.
- Interpret and draw graphs of algebraic and transcendental functions considering limits, continuity, and differentiability at a point.
- Determine and explain whether a function is continuous and/or differentiable at a point using limits.
- Apply differentiation rules to differentiate algebraic and transcendental functions.
- Identify and apply appropriate calculus concepts and techniques to provide mathematical models of real-world situations, and to determine and explain solutions to applied problems.
- Evaluate definite integrals using the Fundamental Theorem of Calculus.
- Recognize and articulate the relationship between derivatives and integrals using the Fundamental Theorem of Calculus.

NOTE: This class meets four times each week. Aside from the four hours that you spend in class each week, you should devote at least another 4~6 hours to studying on your own: reading the book and my lecture notes, working out the exercises and your homework assignments, and solving extra problems for practice etc. You are responsible for all materials/topics discussed in this class.

Active Learning and Inquiry Based Learning: This course implements active learning and inquiry-based learning approaches throughout, and the students are strongly encouraged to preview the teaching materials and be aware of many class participation and self/group study activities.

Course Expectations and Requirements

Class Attendance: You are expected to attend classes as scheduled and be prepared to participate in discussions, in-class exercises, and problem presentations. Attendance is taken in each class. You are strongly encouraged to attend all classes. In addition, if an unavoidable situation prevents you from being on time or if you must leave early, **please minimize class interruption**.

Quizzes: There will be a 15~20-minute in-class quiz emphasizing the most recently covered topics roughly every two weeks, and there will be around 6 in total where only the best 5 of them will be counted as portion for your final grades.

Examinations: There will be two midterm tests during the semester held in regular class: one in Feb and one in Apr, and there will be one comprehensive final exam in the end.

You will take all examinations at regularly scheduled times. Exceptions for a legitimate reason may be granted by and must be approved by me. You will need to notify (or under certain special circumstances have someone else to notify) me formally that you will miss, or have missed an exam and provide a reason, with the accompanying documents supporting that, for your absence within 24-hrs of the scheduled exam date. I can be notified by e-mail, or in person with a written notice. Contact me beforehand to make necessary arrangement if you know in advance that you will be unable to take an exam at the regular class time. Students who fail to follow the prescribed procedure will receive a **GRADE OF ZERO** on the missed exam.

Dates of Midterm Tests: The exact dates will be announced at least a week ahead of time when the time comes both on Blackboard and via email. They can be either in-class 50-minutes exams, taken home projects, and/or hybrid.

Test 1 covers Chapters 1~2(only selected important topics).

Test 2 covers Chapters 3~4 (only selected important topics).

Final exam is comprehensive (only selected important topics).

NOTE: Graphic calculators, cell phones, laptops, i-pads, kindles, and any other electronic/mobile devices are absolutely **NOT** allowed in quizzes and tests. Once found, your quizzes/tests would receive **ZERO CREDIT**. If this happens in a recursive manner, I will report this to the university as an academic dishonesty issue.

Assignments: All homework assignments will be completed online in WebAssign. Read the announcements on Blackboard for all instructions and all due dates are listed in WebAssign. If you cannot finish all the questions, then please try your best to finish as many problems as possible. Do not wait until the last day to start your homework assignments. Work on the problems daily. The homework assignments may be attempted multiple times to increase your homework grade.

Late Assignments: Each assignment worth 100 points, and late assignment will be reduced by 10 points for every day they are late; that is, if it is one day late, you cannot receive a grade higher than 90; if it is two days late, you cannot receive a grade higher than 80, and so on.

Electronic Devices: Cell phones, laptops, i-pads, kindles, and any other electronic devices must be turned off and put away during class. Anyone who is observed text messaging or using an electronic device during class will be given a warning, and as a further action that person will be asked to drop this class.
