### **Course Description:**

This course will examine the development of the third branch of government, the Judiciary. More specifically, the role of the Courts as an institution within the separation of powers in the United States will be analyzed thoroughly. The study of the U.S. judiciary includes the examination of the role of the Supreme Court of the United States (SCOTUS), judicial federalism, and judicial review. Much focus will be on the U.S.'s adversarial, common-law court system and the rule of law. Furthermore, this course will study external factors such as public opinion, partisan politics, interest groups, and the media and their intersection with the federal courts.

# **Student Learning Objectives:**

Students will have:

- knowledge of and ability to analyze the federal judiciary: the constitutional founding of the nation, the role of the Supreme Court, the lower federal courts, and the judicial system as an institution of government.
- ability to evaluate institutions/processes from the perspective of democratic principles, including the 1789 U.S. Constitution, the role that precedent plays in the courts, & the significance of judicial review in the judicial branch.
- understanding of interest groups, the media, Congress, the president, the federal bureaucracy, & the American public's role in the United States government & society.
- knowledge regarding the common-law (or, judge-made law) system with the United States.
- ability to think critically using political science research and professional resources such as indexes, journals, and government documents.

#### Financial Aid and Verification of Attendance:

According to the following federal regulation, 34 CFR 668.21:

U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
