

Course Description

This course is an overview of extreme violent offending, both at the individual and macro levels. The purpose of this course is to gain a deeper understanding of the causes and nature of rare, but extreme forms of violence. Topics include assault and murder, domestic violence, rape and sexual assault, terrorism, and serial and mass murder. We will discuss the social and individual factors that lead to these nefarious acts, and discuss potential preventions.

Course Requirements

NOTE: The course Schedule and due dates will be provided in the Weekly Learning Modules tab on Blackboard.

Your performance in the course will be graded on 15 discussion boards, 15 quizzes, and 1 assignment. Grades are not curved and extra credit is not offered individually.

• Quizzes: There will be quizzes associated with each assigned reading. These quizzes will be posted on blackboard (total of 15 quizzes) and are worth 10 points each. The quizzes will consist of 10 multiple choice and/or true-false questions. Once you begin the quiz you will have 15 minutes to complete it. Since this is an online course the quizzes are open book. With that being said, in order to do well on these quizzes, you need to have read the chapter before starting the quiz. You will only have 20 minutes to take the quiz. If you have not pre-read the chapter, you will not be able to find the answers to the questions quick enough.

Links to each quiz can be found in the weekly folder on blackboard. The specific due dates for the quizzes are highlighted in the weekly learning module on Blackboard. Each quiz link will open every Monday morning and will close at 11:59pm the following Sunday. You will NOT be able to take the quizzes after the window closes. This means late quizzes will NOT be accepted. Since the quizzes are done through blackboard, you may take them any time after they are posted (BUT NOT LATE).

• *Discussion Boards*: There will be discussion boards associated with each assigned reading. Discussion boards are posted on blackboard (total of 15 discussion boards) and are worth 15

points each. The discussion boards will ask you to answer one or more questions based on the reading.

Your grade for each post will not only depend on the quality of your original post. You MUST respond to at least one other student's discussion board EACH WEEK. Your response must go above simply stating that you liked or did not like their comments you will lose points. The goal here is to simulate the discussions that would arise in the classroom.

Links to each discussion threads can be found in the Discussion Boards folder in each module. The discussion board links will open every Monday morning and will close at 11:59pm the following Sunday. You will NOT be able to turn in discussion boards after the window closes. This means late discussion boards will NOT be accepted. Since the discussion boards are turned in through blackboard, you may turn them in any time after they are posted (BUT NOT LATE).

 Assignments: There is 1 assignment worth 100 points. The assignment due date in the Weekly Learning Module tab on Blackboard. More details for this assignment will be provide on Blackboard

Course Attendance & Participation

Although this is an online course, your participation will be monitored weekly via the discussion forum and quizzes.
