Course Description:

This course provides an overview of forensic psychology within criminal and civil contexts. We will examine the fascinating dynamics of human behavior and professional practice within forensic psychology. This topic includes an analysis of the psychology of criminal behavior, as well as current research areas of police and investigative psychology (e.g., eyewitness identification, false confessions), psychology in the courts, mental illness in the justice system, and correctional psychology. Prerequisite: PSYC 2301, and PSYC 3488/or/CRIM 3380.

Objectives:

Upon successful completion of this course, the student will be able to:

- Distinguish forensic psychology from other forensic sciences.
- Understand the many ways psychology contributes to the investigation of crime.
- Describe the role of forensic psychologists working in criminal and civil courts.
- Understand main trends in knowledge and research in forensic contexts.
- Critically assess the credibility of "forensic" information disseminated by popular media.
- Develop critical thinking and analytical skills in the behavioral sciences tradition.
- Identify the range of career opportunities available to forensic psychologists.

Grading:

Each student's grade will be based solely on his/her performance. Students will not compete against one another for grades (i.e., the instructor will not limit the number of As, Bs, etc.). An individual's course grade is based on his or her raw score points (i.e., the total number of points earned during the semester). For example, using the table below, a student who earns 850 points during the semester will earn a "B." A student who has a total of 642 points at the end of the semester will earn a "D" in the course.

DISCUSSION ASSIGNMENT INSTRUCTIONS:

The student will complete 5 Discussions in this course. The student will post one thread of at least 350 words by 11:59 p.m. on Thursday of the assigned week. The student must then post 2 replies of at least 150 words by 11:59 p.m. on Saturday of the assigned week. For each thread, students must support their assertions with at least 2 scholarly citations in APA format. Students are expected to support their discussions with specific references to the **materials** from that week. Each reply must incorporate at least 1 scholarly citation in APA format. Any sources cited must have been published within the last five years. Acceptable sources include classic or ancient literature/books, the textbook, etc.

What Happens If I am Not Getting the Grade I Want?

Here are some pointers:

- 1. **Do all the assignments**. So many students perform poorly because they "forget" to do all the work. Keep up and do assignments.
- 2. If it's multiple choice you are having trouble with, try to **make your own multiplechoice quiz** on the chapter before the test. You won't believe how well you actually have to know the chapter to do that. This means not just the questions—make sure you come up with four possible answers, and that you know which one is correct.
- 3. You are welcome to schedule an appointment to meet with me during office hours especially if you have specific questions, and I plan to offer them on Fridays. I am available at other times too. If you are going to ask me how you can perform better, we will look at your grades, and then I will probably tell you to do #1 and #2. If you need one-on-one study skills help, we have a new office for you to visit! Please see #4 below.

<u>Financial Aid and Verification of Attendance</u>: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
