**Catalog Description.** This course supports students in developing skills, strategies, and reasoning needed to succeed in MATH 1332, including communication and appropriate use of technology. Topics include the study of numeracy and the real number system; algebraic concepts, notation, and reasoning; quantitative relationships; mathematical models; and problem solving. This support course is not a college-level course and should be graded Pass/Fail.

**Prerequisites.** Intended for Non-STEM (Science, Technology, Engineering, and Mathematics) majors. Topics include introductory treatments of sets and logic, financial mathematics, probability and statistics with appropriate applications. Number sense, proportional reasoning, estimation, technology, and communication should be embedded throughout the course. Additional topics may be covered.

Attendance Policy. Attending class is mandatory. In all cases of absences and tardiness or leaving early, students will be held responsible for the completion of course requirements covered in their absence. Students are expected to attend class as scheduled and be prepared to participate in discussions and in-class exercises. If you miss class, you are responsible for finding out what you missed on that day. You are welcome to ask questions about the topics that you missed; however, it is your responsibility to learn the material. You are strongly encouraged to attend all classes. In addition, if an unavoidable situation prevents you from being on time or if you must leave early, please minimize class interruption. After 6 absences, you can be dropped for nonattendance by your instructor without further notice.

**Calculator Policy.** Scientific and graphing calculators are permitted. Some topics may be covered with the assistance of a graphing calculator. Online math utilities (e.g., Desmos) are not allowed on exams. Note: Laptops, cell phones, and other mobile devices are NOT acceptable calculators.

**Homework.** Homework assignments will be assigned and uploaded on Blackboard. Students are required to complete and turn assignments in on the indicated due dates announced by the instructor.

**Examination.** There will be 3 exams and a comprehensive (optional) Final exam. All exams will be in person and administered in class. Unless under extreme circumstances, there will be **no make-up** for exams. Please make sure to coordinate with the instructor **at least 24 hours prior** to the scheduled date and time of the exam. These exams will be closed notes, however students are allowed to work in groups to finish the exam, but each student must turn in their own copy.

Late Work. Late homework submissions will not be accepted. The workload distribution would be in such a way that will allow sufficient time for completion of each assignment.

**Class Policy.** All electronics should be used for **CLASS PURPOSES** only. **Student Learning Outcomes.** Students will explore ways in which mathematics is used in, and is part of, our world and everyday life. We will explore some topics from different areas of mathematics to experience a breath of material that can help us gain a sense of mathematical perspectives and relate to our specific areas of interest. The goal is for students to learn to see not only how useful mathematics is and how it helps us look through different lenses, but also how beautiful mathematics can be. Upon completion of this course, students will:

- 1. Apply the language and notation of sets.
- 2. Determine the validity of an argument or statement and provide mathematical evidence.
- 3. Solve problems in mathematics of finance.
- 4. Demonstrate fundamental probability/counting techniques and apply those techniques to solve problems.
- 5. Interpret and analyze various representations of data.
- 6. Demonstrate the ability to choose and analyze mathematical models to solve problems from real-world settings, including, but not limited to, personal finance, health literacy, and civic engagement.

Financial Aid and Verification of Attendance. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
