Course Description

This seminar focuses on key topics in ecology, including principles of ecosystems, biodiversity, population dynamics, climate change, and human impacts. Through student-led discussions, presentations, and collaborative activities, the course aims to develop critical thinking, scientific communication, and research skills in ecology. This is a discussion-based course, and active participation is essential.

Course Objectives

By the end of this course, students will:

- Understand key ecological concepts and their real-world applications.
- Develop skills in critically analyzing scientific literature.
- Enhance their ability to present ecological research effectively.
- Collaborate on exploring solutions to ecological challenges.

Course Materials

- Assigned journal articles and case studies.
- Access to a computer or device for reading, writing, and presentations.

<u>Financial Aid and Verification of Attendance:</u> According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended the first week of class. Any student receiving federal financial aid who does not attend the first week of class will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Students' Rights

Students' Responsibilities
