**Catalog Course Description:** This course introduces the nature and structure of the US and Texas legal systems; the basic principles of legal reasoning; and laws having a substantial impact on business including contracts, business organizations, and the Uniform Commercial Code.

**Student Learning Outcomes:** Upon completion of this course, you should be able to:

- Understand Business Entities including the advantages and disadvantages of each.
- Identify the difference between Intentional Torts and Negligence.
- Analyze if a valid, enforceable Contract exists.
- Evaluate case problems using Legal Reasoning.

# **Grading Policy:**

- 12 Simulations: Most weeks, students will complte a simulation (also called an ABA) through McGraw Hill Connect. Simulations will be due at 5:00pm on the Fridays noted on the schedule below. You will have two attempts to complete each simulation. Late submissions will be accepted for five additional days (i.e. until the following Wednesday). To be able to complete a simulation after the due date, you must email the professor to be granted access. (Yes, that's annoying, but there are limited settings on Connect for this sort of thing.) Simulations completed in accordance with the late policy will receive half credit. Your lowest simulation grade will be dropped. The average of your simulations will be 25% of your course grade.
- **3 Exams**: This course will have three exams (including a comprehensive Final Exam). Exams will consist of case problem style questions. Exams will be completed in class. Exams 1 & 2 will be 20% of your course grade and the Final will be 25%.
- Attendance: Attendance is required. Attendance will be 10% of your course grade. To be counted as present, you must attend the vast entirety of the class session. Your attendance grade will be the percentage of classes you attended. This means that each class you miss lowers your attendance grade by about 3.57 points. However, there is no penalty for your first two absences. If you must miss additional classes for medical reasons or if you require an accommodation, please provide documentation through the Dean of Students office or Disability Support Services. This is no penalty for absences excused by the University.
- Extra Credit: There is NO extra credit available in this course. [Not even if you email me at the end of the semester asking.]
- **Academic Dishonesty**: Any assignment found to contain plagiarized material or be the result of any academic dishonesty will receive the grade of zero. In addition, two instances of academic dishonesty will result in the grade of F being assigned for the course.

# Make up and Late Assignment/exam policy:

Simulations: Late submissions will be accepted for five additional days (i.e. until the following Wednesday). To be able to complete a simulation after the due date, <u>you must</u> email the professor to be granted access.

Exams: You must provide prior notice if you miss an exam in a non-emergency situation. Failure to do this will result in a 20-point reduction in your exam grade. Any make-up exams should be taken within one week of the schedule exam date. Taking the Final Exam late may result in an incomplete for the course.

Because of an emphasis on critical thinking and problem solving, BLAW 2431 requires that all work submitted by students will be generated by the students themselves, working individually or in groups. Students should not have another person/entity do the writing of any portion of an assignment for them, which includes hiring a person or a company to write assignments and/or using artificial intelligence (AI) tools like ChatGPT. Use of any AI-generated content in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

**Grading Timeframe:** Assignments will be graded and made available to students within two weeks of due date.

<u>Financial Aid and Verification of Attendance:</u> According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. - 4. Each student subject to disciplinary action arising from violations of university student rules shall be assured a fundamentally fair process.

### Students' Responsibilities

- 1. A student has the responsibility to respect the rights and property of others, including other students, the faculty, and administration.
- 2. A student has the responsibility to be fully acquainted with the published University Student Rules found in the Student Handbook, <u>Student Code of Conduct</u>, on our website, and University Catalog, and to comply with them, as well as with federal, state, and local laws.
- 3. A student has the responsibility to recognize that student actions reflect upon the individuals involved and upon the entire University community.
- 4. A student has the responsibility to recognize the University's obligation to provide a safe environment for learning.

5. A student has the responsibility to check their university email for any updates or official university notifications.
