## **Course Description**

An introduction to the major biochemical cycles and pathways in living organisms, including reaction steps, regulation and mechanisms. Prerequisite: CHEM 4341

# Course context as outlined by the American Chemical Society (ACS)

"In the belief that all professional chemists need to know some biochemistry, the ACS guidelines require that approved programs offer and certified majors graduate with the equivalent of three semester hours of biochemistry. Molecular aspects of biological structures, equilibria, energetics, and reactions should be covered in the required biochemistry experience for chemistry majors. Sufficient introduction should be presented so that students can obtain the flavor of modern biochemistry and an appreciation of the important applications in biotechnology".

### **Learning Objectives:**

Students will demonstrate knowledge of basic principles of bioenergetics and metabolism and will be able to perform calculations related to bioenergetics

Students will demonstrate knowledge of building blocks, reactions, mechanisms of major metabolic pathways including: glycolysis, TCA cycle, glycogen metabolism, electron transport/oxidative phosphorylation, gluconeogenesis, pentose phosphate pathway, fatty acid metabolism, amino acid metabolism, the urea cycle and nucleotide metabolism

Students will be able to discuss how metabolic pathways are controlled and the integration between these major metabolic pathways

Students will demonstrate knowledge of how lesions in metabolism can result in disease

Students will demonstrate knowledge of biological information flow

# **Grading**

<u>Financial Aid and Verification of Attendance:</u> According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
