#### **COURSE DESCRIPTION:**

This course will cover U.S. history from before the arrival of the first colonists through the Civil War. Themes to be covered include: colonialism and imperialism, the Atlantic World, trade and economics, politics, diplomacy and warfare, westward expansion, and slavery. We will focus on historical interpretation and critical thinking, rather than merely memorizing names and dates, as so many history classes require you to do.

Upon successful completion of this course, students will be able to:

- 1. Create a thesis argument through the use of historical evidence.
- 2. Analyze and interpret primary and secondary sources.
- 3. Analyze the effects of historical, social, political, economic, cultural, and global forces on this period of United States history.
- 4. Develop analytical writing skills

### **EXAMS**

There will be two exams: one midterm and one final. The exams are given in a format that allow you to demonstrate your understanding of historical topics and to provide your own interpretations of historical

events and themes. It is more important that you be able to exhibit critical thinking skills than to regurgitate a laundry list of names and dates.

Prior to each exam, you will be provided with a study guide.

Exams will not be cumulative, BUT the questions will be based on lecture, the textbook, and the supplementary readings. You will not be able to succeed on the exam by only coming to class and not reading (or vice versa).

#### WRITING ASSIGNMENTS

You will be required to write two essays over the supplemental readings. The first of these writing assignments must be at least 250 words. The second essay must be at least 900 words in length. Both must be double-spaced, with standard 1-inch margins and 12-point font. Cite your sources in footnotes. I will provide a prompt for each of the essays, so you will be using the supplementary readings to respond to a specific historical question. We will discuss these assignments and the citation guidelines in greater detail during class.
