**Course Description:** An independent review of literature and a laboratory or field problem yielding a formal report on the research.

**Course Objective:** The course provides students with the opportunity to develop, conduct, analyze, and interpret research in the exercise science field related to health, fitness, and human performance.

**Learning Outcomes:** Upon completion of this course, each student will be able to:

- 1. Describe the nature of research and explain the scientific method.
- 2. Understand the various steps of the research process and the factors that must be considered when selecting a research question.
- 3. Understand the role of the hypotheses and hypothesis testing in the research process.
- 4. Develop a hypothesis for a research project and synthesize this information to prepare a short review of literature.
- 5. Complete a human subjects application and attain simulated approval through the A&M-SA IRB.
- 6. Test a hypothesis and obtain data, analyze, and interpret results by carrying out a small research project in a specific exercise science-related topic.

**Assignments:** All assignments (e.g., presentations, IRB, CITI, review paper, etc.) are due at set specific times throughout the semester. Details of each assignment will be provided in class.

# Of note, late assignments will not be accepted (i.e., 0 point).

**Extra Points:** If you participate in research (and submit the evidence of participation) from the Kinesiology program, extra points will be added to your final points for the grade.

**Academic Dishonesty:** Students are expected to do their own course work. Academic dishonesty (e.g., cheating, plagiarism, fabrication, lying, bribery, threat, etc.) is a violation of the Student Code of Conduct; therefore, the instructor will report any form of academic dishonesty to the Office of Student Rights and Responsibilities.

<u>Financial Aid and Verification of Attendance:</u> According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
