Catalog Course Description:

This course will examine the evolution of emergency management, homeland security and emergency response in the wake of the events of 9-11 and Hurricane Katrina. It will survey multiple disciplines involved in the disaster processes and future directions in these fields. Students will also examine the success and failures of emergency management by examining such incidents as World Trade Center Attacks, Pentagon Attacks, Hurricane Katrina, Hurricane Ike, Los Angeles Riots, and other emergency events that have shaped the relationship between the fire service, emergency management and the Federal Government.

Prerequisites:

None- This class is intended for BAAS-FESA students. Others may attend with the approval of their respective school or department.

Course Format:

Online – Asynchronous: The course will be delivered through the University's Blackboard Academic Suite. Only students who are enrolled at TAMU-SA and registered for this course will be given access

Student Learning Outcomes:

After successful completion of this course, students will be able to:

- Explain and analyze the preparedness model.
- Identify and analyze resources for preparedness. Compare and contrast the similarities and differences between disaster planning and terrorism planning.

- Identify and evaluate sources of information used in Homeland Security.
- Discuss how the National Incident Management System and the Incident Control System are used to integrate the necessary components of planning for Homeland Security and emergency preparedness.
- Explain information sharing regulations used in law enforcement and national security and evaluate their effectiveness.
- Identify, assess, and rank critical infrastructure and other significant targets in order of vital significance and vulnerability to support allocation and effective use of protective sources

AACSB Assessment:

The College of Business is in the process of applying for AACSB accreditation. As part of that process, students will be assessed on program level outcomes based on course outcomes from various courses. The materials from this course may be used for assessing such program level outcomes, and hence students must follow the necessary rigor to ensure mastery and retention of the above course outcomes.

- Time Expectation for coursework: You are expected to spend 4-8 hours per week on the course. Based on the background, some students may require more time. Time spent may be longer when assignment/exams are due.
- Other Recommended / Reading Materials: Additional reading materials are available on the course website as recommended by the instructor.

Course Requirements every student must fulfill to succeed in course:

1. Students should check the Course Calendar, Announcements, and Messages (e-mail) systems in Blackboard on a regular basis.

- 2. Students should keep current with all course assignments, guizzes, and examinations.
- 3. If the course uses remote proctoring for exams, students must schedule their exam early in the semester.
- 4. Students should ask questions and communicate with the instructor either in class, online, off-line or during office hours.
- 5. For all classwork, exams, quizzes etc., if a student is completing it off-campus, then they are responsible for availability of internet connectivity. Extensions will **not** be granted for lack of availability of internet connections.

- 8. For online asynchronous courses, there will be no online class sessions. All materials will be made available through Blackboard or through online links.
- 9. For online synchronous courses, there will be online class sessions as indicated. Students are expected to attend the online session at the given time. If a student is unable to attend a session, the instructor will make the recording of the session available for the student to view. All materials will be made available through Blackboard or through online links.

Grading Policy: The final course grade will be based on your performance on the quizzes, exams, assignments and class participation using the following weights:

The final letter grades will be assigned as follows: Above $90\% \Rightarrow A$; $80 - 89\% \Rightarrow B$; $70 - 79\% \Rightarrow C$; $60 - 69\% \Rightarrow D$; Below $60\% \Rightarrow F$.

This course has a requirement of a grade of C as a minimal grade for satisfactory completion of this course.



EXAMINATIONS:

There will be online quizzes through Blackboard. The exams/quizzes will consist of conceptual multiple-choice questions, and short essay questions. The exam/quiz materials will come from lecture notes, the text, and discussions. Questions will emphasize understanding and applications of concepts and topics covered in class.

ASSIGNMENT:

There will be individual or group assignments during the semester. The objective of the assignments is to analyze and respond to various case studies outlined in the text, or as assigned by the instructor. Details of the assignment will be provided later.

RESEARCH PAPERS:

This course will require the completion of two (2) research-based papers. The papers will focus on the relationships between Homeland Security events, Emergency Management and the materials presented in the class. Topic selection and research criteria will be presented later in the course.

CASE STUDY PAPERS:

During the class there will be several case study analysis' papers assigned. The case study is designed to complement the research assignments. Students will be given ample opportunity to develop case study assignments into the research papers. RUBRICs and scoring guides will be discussed in class.

Make up and Late Assignment/exam/quiz policy:

As a rule, make-up or late submissions will be accepted but will receive an automatic 15%-point deduction. Late submissions or make-up may be accepted/administered only in extra-ordinary circumstances such as an excused official university activity, a severe illness, or a dire emergency. However, you must provide comprehensive documentation either before or within a few days of the missed assignment/quiz/exam to receive exemption from the late penalty.

Class conduct and civility code: Everyone in class is expected to follow all rules in the student handbook, as well as common courtesy during classroom lectures and discussions in class and online, including the following:

- 1. It is the students' responsibility to obtain and be able to use the required materials and software for this class.
- 2. Student must retain copies of all assignments and graded work for verification purposes. Keep copies of all computer files and e-mails.

Active participation will be rewarded when final grades are assigned. The course is intensive and challenging and you are expected to master the materials presented in class. The structure of the class makes your individual study and preparation outside of class extremely important. Reading the assigned chapter(s) and having some familiarity with them before class will be very useful for understanding lectures.

OTHER CLASS POLICIES:

- Everyone in class is expected to follow all rules of common courtesy interacting in the class and online. Anyone violating these policies may be subject to disciplinary actions.

The structure of the class makes your individual study and preparation extremely important. Reading the assigned chapter(s) and having some familiarity with them before class will be very useful for understanding ideas and presentations.
- The instructor will post lecture materials appropriate to the class on the Blackboard site.
- The course covers a lot of material, and most students find at least some parts of it difficult. Your participation is highly encouraged in the discussion board portion, as it makes class more interesting and enhances the learning experience. I encourage you to ask questions, participate in online discussion and problem solving.
- There will be several opportunities for instructor and student interaction through chat sessions and virtual classroom sessions. Although these sessions are not mandatory, they help in the learning process. Students will be provided adequate notification of session dates.
- The provisions and information set forth in this schedule are intended to be informational and not contractual in nature. I reserve the right to amend, alter, change, delete or modify the provisions of the schedule. All the changes will be announced through Blackboard Announcements, and you are responsible for the announcements made in this manner.

General Guidelines for Online Discussions

- 1. Do not only respond to my questions, but rather carry on a dialogue with your classmates as well. This is a discussion, not just a question-and-answer session. It is one of the items that make a good online course and establishes community. If you only respond to my question, it makes our discussion more of an "exam" rather than a dialogue.
- 2. Do not get caught up in "winning" the debate. We are here to learn the material, to discuss matters of importance with others, and to enjoy learning.
- 3. Read at least 3-4 postings from your classmates, not just those from me. We all learn from each other's perspectives and experiences.
- 4. If you have questions over the reading material, direct your inquiries to me as soon as possible.
- 5. When you reply to a post, don't just say "I agree." Give the person or person's name you agree with, a brief sentence or two, summaries of what they said you are agreeing with, and then your views. You might also consider changing the subject line to reflect your posts. Make it easy for us to figure out who you are talking to and what you are talking about.
- 6. Depending on the course you are enrolled in, you should plan on having your posts completed by the date indicated in the Module—NO LATER. Three posts are the bare minimum—one originating with you and two responses to classmates. Therefore, more is expected for a discussion grade of "C". Late posts do not count and thus a poor grade is recorded. You should also plan on posting on more than one or even two days to allow yourself to stay involved with the class.
- 7. Try to keep each post to no more than one or two screens. I will do the same.
- 8. If you express an opinion, support it with material from our readings. When you quote, summarize, or paraphrase from the text be sure to give the page number(s) --This is important!
- 9. When in doubt, ask. If your classmates cannot answer your question, then I probably can.
