**Course Overview**

Origin and development of the U.S. Constitution, structure and powers of the national government including the legislative, executive, and judicial branches, federalism, political participation, the national election process, public policy, civil liberties and civil rights.

2. The federal system
3. Separation of powers and check and balances in both theory and practice

**Course Requirements**

Quizzes - There are 12 weekly quizzes in this course. Each quiz will cover the chapter for that week and any additional reading assigned. Each quiz is worth 20 points with 15 multiple choice/true false questions each worth 1 point and a short answer question worth 5 points. The quizzes are taken through blackboard, are timed, and are available on Monday at 6am and are

due on Sunday at 11:59pm. Students are to work on the quizzes on their own. I will drop the two lowest quiz scores and there are not make up quizzes available (200 total points)

Writing Assignments – There are two writing assignments in this course. Each assignment will be open the week it is due on Monday and then due the Sunday of that week on Blackboard at 11:59pm. Each assignment will be approximately 2-4 pages in length and worth 30 points each (60 total points).

Discussion Board Posts – Each Monday I will post a discussion question related to the weeks topic. Students are required to post at **least 2 responses**. One to the original post by me and one post to one of your fellow classmates post. These responses will be graded and are worth 10 points each. Your online participation will be evaluated on a quantity and quality basis. Your comments should advance the discussion, add value, and be relevant. Comments such as "I agree" and "ditto" are not considered value-added participation. Therefore, when you agree or disagree with a comment, please state and support your agreement or disagreement. The posts are due on Sundays at 11:59pm (240 points total)

### **Attendance Policy**

This course is online and asynchronous so there is no attendance *per se*. However, the class is structured for students to progress through specific topics weekly. This is not a class you can put off until the end of the semester and try and race through to finish in the last few weeks. You must “attend” to the assignments weekly.

### **Rules and Guidelines for (Blackboard) Discussion**

Use the following conventions when composing a discussion posting:

1. During a Discussion assignment, deadlines for posting to and replying will be specified with each assignment. It is a good practice to always check the Discussions multiple times during the week.
2. If you want to send a personal message to the instructor or to another student, use e-mail rather than the discussions
3. Use the appropriate Discussion Topic; don't post everything on the "Main" Discussion Topic.
4. Be patient. Don't expect an immediate response when you send a message.
5. A helpful hint for use with both discussions and e-mail --- Compose your message in your word-processing application in order to check spelling, punctuation, and grammar -- then copy and paste your composition into e-mail or the discussion. This also saves online time.
6. Everyone should feel free to participate in online discussions. Regular and meaningful discussion postings constitute a substantial portion of your grade.
7. Respect each other's ideas, feelings and experience.
8. Be courteous and considerate. It is important to be honest and to express yourself freely, but being considerate of others is just as important and expected online, as it is in the classroom.
9. Explore disagreements and support assertions with data and evidence.
10. "Subject" headings: use something that is descriptive and refer to a particular assignment or discussion topic when applicable.
11. Use the "reply" button rather than the "compose" button if you are replying to someone else's posting.
12. Do not use postings such as "I agree," "I don't know either," "Who cares," or "ditto." They do not add to the discussion, take up space on the Discussions, and will not be counted for assignment credit.
13. Avoid posting large blocks of text. If you must, break them into paragraphs and use a space between paragraphs.

### **Penalties for Academic Dishonesty**

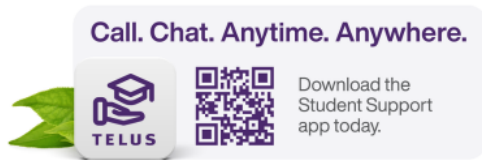

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended the first week of class. Any student receiving federal financial aid who does not attend the first week of class will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

**The Six-Drop Rule:** Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

4. Each student subject to disciplinary action arising from violations of university student rules shall be assured a fundamentally fair process.

#### *Students' Responsibilities*



1. A student has the responsibility to respect the rights and property of others, including other students, the faculty, and administration.
2. A student has the responsibility to be fully acquainted with the published University Student Rules found in the Student Handbook, [Student Code of Conduct](#), on our website, and University Catalog, and to comply with them, as well as with federal, state, and local laws.
3. A student has the responsibility to recognize that student actions reflect upon the individuals involved and upon the entire University community.
4. A student has the responsibility to recognize the University's obligation to provide a safe environment for learning.
5. A student has the responsibility to check their university email for any updates or official university notifications.
