

BIOL 4101: Seminar in Integrative Biology (Credit hour 1)

Course Outcome and Expectations:

Students will learn to critically evaluate scientific articles and prepare for successful grant writing

This course is designed to develop students' critical thinking skills. It emphasizes identifying and formulating scientific research questions, critically analyzing journal articles, developing hypotheses, crafting persuasive grant proposals, and understanding the grant submission process. Students will be assessed on their ability to effectively communicate ideas to a general audience through scientific presentations, research article discussions, and the creation of a compelling grant proposal. Qualifying in all these components are **MUST** to pass this course.

Learning Objectives:

- Understand the component of a grant proposal
- o Critically review journal articles and a research proposal
- o Developing a scientific question of broader impact
- Practice oral and written scientific communication to the scientific and non-scientific audience

Evaluation: (Total 100 points)

Active class participation: 20 points

This will include discussion of journal articles, interpretation of research ideas and peer reviewing.

Weekly Assignments: 40 points

This will include in-class activities and homework assignments.

Final Grant proposal: 40 points

This will include submission of final draft of the proposal and a 10 min synthesis of the research idea as an oral presentation

Course policies:

- Policy on grade appeal: If you believe an error was made in grading, please do not hesitate to bring it to my attention as soon as possible. If you struggle with this course, please let me know and do not wait till the end of the semester. For an assignment, you are welcome to inquire why points were deducted, but all grades will solely be based on the work submitted at the time of assignment. No verbal clarification of answers will be taken into consideration at a later time point.
- o <u>Policy on make-up or late assignments:</u> All assignments are due on the schedule date unless discussed with Dr. Mukherjee ahead of time.

- Attendance Policy: Failing to attend class without prior discussion with Dr. Mukherjee will automatically lead to loss of points from 'active class participation'.

<u>Financial Aid and Verification of Attendance:</u> According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution

must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended the first week of class. Any student receiving federal financial aid who does not attend the first week of class will have their aid terminated and returned to the DoE. Students' Rights

Students' Responsibilities

- 1. A student has the responsibility to respect the rights and property of others, including other students, the faculty, and administration.
