## COURSE DESCRIPTION

This course offers an introduction to certain vital aspects of the history of the United States from European colonization to the end of the Civil War. It will focus on four: the nature and impact of European colonization; how the U.S. came to be an independent nation; how slavery almost destroyed that nation in the 1850s and 1860s; and how the U.S. has continually struggled to deal with its diversity. Through the textbook and readings, students will be exposed to the different ways that historians "do" history; thus, we have works widely regarded as a model of the new "inclusive" history. To give you the experience of working with primary sources, the "stuff" of history. Toward that end, we are reading the autobiography of Frederick Douglass.

The greatest problem of a course that attempts to cover over three hundred years of U.S. history in 18 weeks is that exceedingly hard choices have to be made. We cannot deal with everything that most historians would consider essential in a survey of American history, let alone all of the topics that are interesting and rewarding. Thus, I emphasize that this is an introduction to U.S. history that I hope will encourage you to explore certain aspects of it in greater depth in other courses or on your own.

## LEARNING GOALS

Upon successful completion of this course, students will:

1. Create an argument through the use of historical evidence.
2. Analyze and interpret primary and secondary sources.
3. Analyze the effects of historical, social, political, economic, cultural, and global forces on this period of United States history.

### **Attendance Policy (10%):**

I take attendance every class period. The course meets twice per week, so up to four absences are allowed. Being absent more than that will affect your attendance grade and make it difficult for you to do well in the course. The Learning Management System will automatically drop the lowest 4 absences so there is no need to email me if you will be out.

### **Quizzes (20%):**

Students will take 4 low-stakes quizzes primarily based on the readings and lecture: Feb. 5, Feb. 26, March 5, and April 23. Quizzes are short, approximately 5-10 questions, proctored at the start of class. Quizzes will equip you for unit examinations. You may drop the lowest quiz score.

### **Exams (55%)**

You will have three in-person unit exams. Exam 1 (15%) Feb. 19, Exam 2 (20%) March 19, and Exam 3 (20%) May 5. The exams will be a mix of multiple choice, T/F, matching, short-answer, and essay questions. You will receive a study guide and review to help you prepare for the examinations. Students will need to bring a scantron, a blue book, and a number 2 pencil to the three exams.

### **Frederick Douglass Quiz & Essay Exam (15%)**

Students will complete a book quiz, (5%), April 2 consisting of 10 short answer questions proctored in the first twenty minutes of class. Students will complete a longer in-class essay exam, (10%), April 14 to assess understanding of argument, content, historical context, and citation. Students will need a blue book for the essay exam. Make-up essays only are allowed for emergencies such as debilitating illness, a death in the immediate family, and religious or school functions. In any case, documentation must be provided in order for the student to be allowed a make-up essay.

### **Extra Credit Public History Field Trip:**

Students will have an opportunity to take a field trip to the Briscoe Western Art Museum and view Gallery Exhibits on Level 3: Guerra Family and A-Bar. Through the artwork, students will engage with the influence of Spanish, American, Mexican, Tejano, and Indigenous history as it developed throughout

the Southern Borderlands region. Learn about the Battle of the Alamo, the Texas Revolution, and the broader cultural history of the Texicans, who resided in and immigrated to the area before 1846. Museum is located at 210 W. Market Street, San Antonio, TX 78205 see <https://briscoemuseum.org/hours-admission/> Trip is scheduled for 4/6 @ 2 PM. Meet near Welcome Center. Text 210-279-8044 for further information. Note that Sunday's Museum hours are 10 am to 5 pm, the museum is free on the first Sunday of the month for locals. There will be a short assignment based on the experience due April 30. Points will be added towards Exam 3.

### **Make-up Exam Policy:**

Exams only will be given on the date assigned on the course calendar. Makeup exams only are allowed for emergencies such as debilitating illness, a death in the immediate family, and religious or school functions. In any case, documentation must be provided in order for the student to be allowed a make-up exam. Missed exams must be made up within a week at the testing center. The testing center does not accept walk-in's. Students must register 12 hours in advance of the day you want to test. Once you have scheduled the test, send me a courtesy email to let me know what day to expect it so that I can pick it up. As you noticed, these are all steps that are initiated by the student, and not the professor--that's more work on the student. At the discretion of the instructor, the make-up exam may not be the same format as the class exams. The Testing Center exam is the final make-up available so if you miss this second opportunity, you will receive a 0.

**Blackboard:** This course has a Blackboard site. The syllabus, additional reading assignments, and study guides will be posted there, as well as announcements and grades throughout the semester. I do not post lecture notes online—you must attend class and take your own notes. If you are absent, you will need to get lecture notes from someone else in the course.

Laptop computers may only be used during class time to take lecture notes. Any other purpose is not allowed.

You must have Jaguar email account ready and working. The instructor will distribute course materials, including announcements and updates, via Blackboard, so students should log in to the course site in Blackboard regularly.

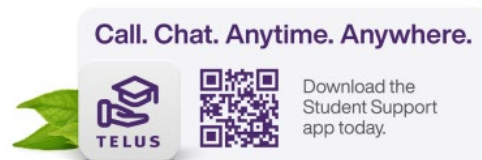
