**Course Description:** This course will provide an overview of introductory logical concepts, which will include sentential logic, validity, well-formed formulas, the semantics of logical notation, natural deduction and more. By the end of the course, students will be able identify logical arguments, argument forms, and proper reasoning, using the tools given to them throughout the course.

**Required Texts:** The texts for this course will be Graeme Forbes *Modern Logic: A Text In Elementary Symbolic Logic*. This will be provided on blackboard.

**Course Requirements:** There will be 10 quizzes (25%), two midterm exams (50%) and a final exam (25%). Due dates for the midterms, final exam are scheduled below.

### Classroom Procedures

**Late Assignments/Extra Credit:** Late assignments will not be accepted without a doctor's note, or some requisite indication of an emergency. There are no plans for extra credit assignments, though there will be extra credit questions on exams.

**Participation:** Participation will be required, so it is imperative that you familiarize yourself with the material and keep up with works assigned for reading. The expectation is that students will be able to understand the logical structure of various arguments and constructing their own arguments.

**Attendance:** Attendance is highly encouraged, as the material will likely invite questions that are best cleared up in person and on the spot.

**Classroom Etiquette:** Distractions, such as phones, alarms, and other electronic devices will generally not be tolerated. Any exceptions will need to be cleared with me before class. Written notes would be preferred to notes taken on laptops, but laptops are allowed. Cheating will not be tolerated. Use of AI tools (such as Chat GPT, for example) to complete assignments will be considered a form of cheating.

The topics we discuss may involve talking about issues which are sensitive. These topics should be discussed with respect, courtesy, and understanding for different perspectives. Insults, dismissiveness, and similar attitudes will not be tolerated.

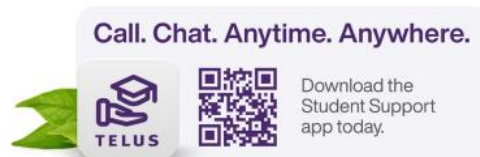

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. **Option 1 - No Use of Generative AI Permitted**

[Insert Course Number] assumes that all work submitted by students will be generated by the students themselves, working individually or in groups. Students should not have another person/entity do the writing of any portion of an assignment for them, which includes hiring a person or a company to write assignments and/or using artificial intelligence (AI) tools like ChatGPT. Use of any AI-generated content in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

**Option 2 – Use of Generative AI Permitted Under Some Circumstances or With Explicit Permission**

There are situations and contexts within this course where you may be asked to use artificial intelligence (AI) tools to explore how they can be used. Outside of those circumstances, you should not use AI tools to generate content (text, video, audio, images) that will end up in any student work (assignments, activities, discussion responses, etc.) that is part of your evaluation in this course. Any student work submitted using AI tools should clearly indicate with attribution what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, students should reach out to their instructor for clarification before submitting work for grading. Use of AI-generated content without the instructor's permission and/or proper attribution in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

### **Option 3 – Broader Use of Generative AI Permitted Within Guidelines**

Use of artificial intelligence (AI) tools, including ChatGPT, is permitted in this course for students who wish to use them. To adhere to our scholarly values, students must cite any AI-generated material that informed their work (this includes in-text citations and/or use of quotations, and in your reference list). Using an AI tool to generate content without proper attribution qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

### **Option 4 – Customized Policy Generative AI Policy**
