CATALOG DESCRIPTION: In-depth study and applications of inverse functions, and exponential and logarithmic functions. Trigonometry is an additional major topic mainly including angle measurement, trigonometric functions and their graphs, inverse trigonometric functions, trigonometric identities and equations, and law of sines and cosines.

PREREQUISITE: MATH 1314 College Algebra with a grade "C" or higher.

REQUIRED TEXTBOOK: Pre-Calculus Essentials by Blitzer, 6th edition. ISBN: 9780136906551

ONLINE PLATFORM: Pearson Mylab Math, https://mlm.pearson.com/northamerica/mymathlab/ Electronic book is there. Only use university email to register. Use the same name as appearing in your student ID to register. Do not use personal emails. Homework will be assigned through this website.

STUDENT LEARNER OBJECTIVES: Upon completion of this course, students will:

- 1. Demonstrate understanding and knowledge of properties of functions from graphical, tubular, symbolic, or verbal representations
- 2. Identify and apply appropriate strategies for solving equations involving algebraic, transcendental, and trigonometric functions.
- 3. Interpret and apply graphing techniques or algebraic and transcendental functions
- 4. Compute and apply the values of trigonometric functions for key angles in all quadrant of the unit circle measured in both degrees and radians.
- 5. Prove and apply trigonometric identities
- 6. Interpret and solve applications related to right and oblique triangle

MATH 2312 helps students develop critical thinking, communication, and empirical and quantitative skills by focusing on student understanding of key mathematical concepts required for Calculus readiness to include recognizing, identifying, solving, analyzing and explaining appropriately model applicable real-world situations.

LIST OF TOPICS: Topics to be covered approximately include but are not limited to the following:

- 1. Functions and relations
- 2. Inverse functions
- 3. Exponential and logarithmic functions, and their properties

- 4. Exponential and logarithmic equations with applications
- 5. Angles and their measures
- 6. Trigonometric functions and right triangle trigonometry
- 7. Trigonometric functions of any angle
- 8. Graphs of sine and cosine and other trigonometric functions
- 9. Inverse trigonometric functions
- 10. Trigonometric identities
- 11. Trigonometric equations
- 12. The laws of sines and cosines

Note: The instructor reserves the right to modify/update the topics as appropriate.

CALCULATOR: A scientific non-graphing, non-programmable calculator is required and allowed on all exams. No cell phone, laptop, or graphing calculator will be allowed, and online math utilities (e.g., Desmos) are also not allowed. Students are responsible to bring their own scientific calculators. The instructor does not provide scientific calculators. Students can also try to check whether the library has a scientific calculator to borrow.

UNIFORM FORMULA SHEET: The instructor will provide a common formula sheet for all tests and the final exam. No other formula sheet is allowed. Please understand and remember all other formulas deeply by yourselves.

GRADING POLICY: Final grades will be based on two midterm tests, weekly HWs, quizzes, attendance, and the final exam. The final will be comprehensive. Late HW will result in substantial penalty automatically performed by the online platform. Ratios are: tests 30%, HW 30%, quiz 10%, attendance 5%, and final 25%.

HW extension policy:

For each HW, it is due in about one week after it is assigned (the actual length may vary based on needs). For most of the HWs, there is another one-week automatic extension after the due date for students to work on. However, there is 15% penalty each day for the eared credit after the due date. The policy is the same for everyone. There will be no other HW extension beyond this automatic extension except very serious documented excuses informed to your instructor before the HW is due. *Informing the instructor after the regular one-week due date is invalid*.

Quiz policy:

We have weekly quizzes in most of the weeks. **There is no make-up for the quizzes**. Two lowest quiz grades will be dropped for each student. Any initially missed two quizzes can be considered dropped-out quizzes with grade zero.

Midterm test extension policy:

Tests can only be rescheduled for a later date in case of student illness, family issues, attending University events, or other significant cases approved by the instructor. An official document is required for the excuse. Students have to immediately inform the instructor about the circumstances and negotiate the day of the makeup. Notice to the instructor for make-up after the regular test/final time is not acceptable. Makeup cannot be made 5 weekdays later than the regular test dates.

Suggested Learning Strategy:

Be advised that college math learning is different from high school learning in some extent. It requires much initiative from the students to not only really remember the principles, but also **understand** the

theory, and finally apply it to solve abstract/practical problems independently. So be hard-working to read and understand the class-notes and textbook. If you have a wrong problem in HW, test, or quiz, understand why, and know the right way to solve it. Feel free to talk to your instructors in their office hours, and use the online platform to self-learn if necessary. Solve the problem; don't accumulate it. In summary:

- Review the classnotes regularly;
- Read the textbook to enhance understanding (more detailed materials);
- Finish homework on time. Don't wait to the last minute to do it. Understand why your solutions are wrong and how to find the correct ones;
- Discuss with your instructor or classmates for difficult concepts.
- Only you yourself deeply know if your study is enough or not. Take action to strengthen yourself in learning effect. Aside from the regular class time each week, you should devote at least 6-8 hours weekly to studying on your own.

How to prepare for mid-term exams and the final exam:

- Review all our class notes, and deeply understand the materials before the tests.
- Also try to work out the examples in the notes and compare your answers with the answers in the notes.
- Many test problems will be similar to HW/classnote problems. Please understand the HW problems deeply and make sure you can work out the problems correctly without resorting to the help resources.
- •You can also use Study Plan in your Pearson account to practice extra problems for the sections covered in the test (path: Study Plan—>All Chapters).
- Check your solution carefully before you write your answer to make sure it is right by your understanding.
- Pay attention to the detail. Follow the requirement of the answer format like how many decimal places are needed.


